However at the time of printing, negotiations with the employer groups have not resulted in any agreement.

The hearing resumed on 27 February. Young Lawyers made its own submission, independent of the employer group and Australian Services Union submissions. As this is an important issue which will affect most young lawyers, the Young Lawyers Section will keep its members fully informed of further developments as they come to hand.
