One of the exciting opportunities offered by AIJA membership is participation in the trainee exchange program (SPES). The SPES actively organises foreign work placements for young lawyers who wish to gain professional experience abroad.

#### **Future congresses**

The Association's 1997 congress will be held in Florence, Italy, a city which needs no introduction. The congress will be held 1-6 September 1997 and the working sessions will be devoted to one of the most stimulating legal topics of our time: "New Technologies and the Law".

The major working sessions will cover issues such as Bioethics, Cyber law—are you on line?, The Impact of New Technology on the Employment Relationship, New Technologies and Data Protection, Acquisitions of New Technology Companies, Liability for High Technology Goods and Moving towards a Universal System of Registration of Security over Goods.

The opening ceremony of the congress will be held at the historic Palazzo Vecchio, the Florence town hall, in the Salone dei Cinquecento, the vast elaborately decorated council chamber built in 1495.

There will also be a reception at the Pitti Palace and a very special evening is planned to take place on the Ponte Vecchio, the magnificent bridge spanning the Arno.

Among the other social activities will be a trip through the Chianti region to explore some of the magnificent Tuscan villas and taste the special wines.

The great news for young lawyers in Australia is that Sydney will host the 1998 AIJA congress from 20 to 25 September 1998. We are very excited about the prospect of hosting an international event for hundreds of young lawyers from all over the world.
