Mid-year Review

We had our mid-year reviews recently at work. That exercise prompted us to think about how closely the Young Lawyers Section has adhered to our stated aims at the start of the year. As a section, we had three major goals for the year. For the sake of those who may have forgotten they were:

- implement the pro bono referral scheme;
- raise the level of debate on constitutional and republican issues; and
- explore ways to link up more with other young lawyer sections interstate.

Here's an update of where we are at:

Pro bono referral scheme:

We hope you have returned the survey forms which were sent out to every practitioner to gauge the level of interest in such a scheme. The results of the survey are being analysed and a report is being prepared for Council's consideration. The indications are that there is a high degree of support for such a scheme and we plan to present the results to Council later this year. Perhaps the most memorable response was from Mr Tom Molomby, senior partner of Molomby & Molomby. Tom thought it was a great idea and he would have no hesitation in doing it if only he was twenty years younger! It's never too late Tom.

The republic:

The Editorial Committee are to be congratulated on the high quality of this journal particularly the last issue devoted to republican and constitutional issues. Making links:

We had the pleasure of recently hosting a delegation from the Young Lawyers section of the Law Society of New South Wales.
