Pro Bono Referral Scheme

We hope that the Scheme will be launched early in the new year and will progress without hindrance from bureaucratic red tape. We hope to see the Scheme supported enthusiastically by our members and we are in the process of developing a package to assist employee solicitors to broach the issue with their employers.

The republic issue is coming to a head, with voting for the delegation currently in progress. The Section has a number of exciting proposals to ensure inspired and educated debate continues within the ranks of the Young Lawyers and the profession in general next year.

Making Links
