The discussion will focus on risk management in regard to lateral movement of lawyers, mergers and lawyer dissatisfaction as well as the issues involved in managing client relationships to minimise client defection. #### **Effective presentations workshops**

## Mediation role-play – 26 May

The Institute's ADR Committee is pleased to announce it has arranged for a mediation role-play to take place on 26 May 1999 at the Institute from 5.30-7pm. The session is targeted towards young lawyers who practice in litigation or are interested in mediation. It is designed to promote discussion about the process of mediation. The role-play will be presented by the young lawyers of Deacons Graham & James and a discussion will be led by Jonathan Mott a partner at the firm, and highly regarded mediator. The role-play centres on a dispute concerning the use of non-union labour that has erupted over the construction of a casino on the shores of Lake Burley Griffin. The cabinet minister in charge of the project is keen to see the dispute settled so the casino can be finished and funds can begin to flow to the government's almost bankrupt administration. The role-play roughly follows the course that a real mediation might, and, as the audience quickly discovers, the plot and characters are completely fictitious! #### Mediation Workshops – May and October

The Institute in association with the Accord Group Australia will be conducting two Mediation Workshops this year.
