Law Reform Committee Report

T has been a busy year for the Law Reform Committee (LRC), with members currently working on the following projects:

- The environmental issues sub-committee is working on a submission to the Victorian government on mandatory energy efficiency standards in commercial buildings. The submission focuses on changes to the Building Code of Australia and possible changes to planning schemes, and compares interstate and overseas energy efficiency standards.
- The discrimination in the law submission to the Scrutiny of Acts and Regulations Committee

(SARC) was sent to the SARC on 1 September. Amendments were required due to the controversial nature of some of the recommendations.

- A training session on preparing and writing submissions was held on 16 September 2004.
- The LRC is supporting One Umbrella in advocating the nationalisation of the good samaritan legislation. The legislation only exists in Victoria and allows businesses to donate food safely for a charitable purpose without fear of liability. The LRC is drafting letters to be sent to the law societies in the other states and territories,
- encouraging them to lobby their own governments.
- Several of the LRC members have worked with other young lawyers to organise the 22 September 2004 Hypothetical – Law on Terror.

The Co-Chairs are grateful for the enthusiasm, dedication and hard work of the members this year and are looking forward to nominating interested members for the position of LRC Cochair/s for 2005.
