## ACT BRANCH

### Copyright Workshop

A one-day workshop on Copyright for Librarians will be held on Friday, 16 July at the National Library of Australia.

Organised by the ACT Branch of the LAA, it will follow last year's successful workshop on the implications of the Copyright Amendment Act. Many who attended last year's workshop have requested a follow-up workshop to look at the situation after the Act has been in force for some time.

The workshop will also look at areas not covered by the Amendment Act, notably those of Copyright and Computers and Copyright in relation to Audio-Visual Materials, in the latter case with particular reference to the issues paper currently being prepared by the Attorney-General's Department.

Keynote speaker is to be Rob Brian, Law Librarian, University of NSW and author of the Copyright Kit prepared by the LAA.

Fees: Full day, members \$25, non-members \$40. Half day, members \$10, non-members \$16. (The half day fee does not include lunch.)

More details will appear later as speakers and sessions are confirmed.

### Librarians and Redundancy

The University and College Libraries Section arranged a very successful meeting which addressed the question of libraries and redundancy – a problem which for this group of librarians has been escalated by the Razor Gang's cuts in the tertiary education sector.

The guest speakers, Pam Sandon, the Industrial Officer of the Victorian Colleges Staff Association, and the LAA's Industrial Officer, Judith Hill, were both very open and honest about the problems as they saw them. One major difficulty is loss of positions when staff leave and are not replaced. Another problem was that of casual and temporary employees having no safeguards vis à vis job security.

As Judith pointed out, the LAA cannot help individuals who are made redundant – that is a union matter. Possible actions Judith suggested include the formulation of an Amalgamation Statement, and a Statement on Staffing Standards for university and college libraries and much clearer channels of communication being established with the Tertiary Education Commission and State Tertiary Education Bodies.

### Continuing Education

A full and varied programme has been planned for the coming year including seminars on libraries and industrial relations, and on managing people at work. Full details will be given in *Happenings*.

### School Libraries' Surveys on Staffing

## NSW GROUP, SPECIAL LIBRARIES SECTION

The Copyright meeting on February 10 at Allen, Allen & Hemsley was addressed by Rob Brien, University of NSW Law Librarian and about 80 people attended. A good question and answer session laid emphasis on the still unresolved problems of the Act and its recent amendment.

On March 3 Judith Hill, LAA Industrial Officer, spoke to about 40 people at the meeting at the Commonwealth Bank on the development of unions in libraries, the pros and cons of library unions and the possibility of amalgamation with other unions to cover librarians in private industry. The question and answer session which followed showed a lot of interest in this subject.
