A win for the Friends of the Noel Butlin Archives Centre

The Australian National University has announced the establishment of the ANU Archives Program, bringing together the university archives and the Noel Butlin Archives Centre (NBAC) from 1 August 2001. The university archivist heads the Archives Program, reporting to the pro vice-chancellor (administration), Chris Burgess. Recurrent funding for the program has been allocated, ending uncertainty about the future for the NBAC and its staff. Funds have also been made available for capital works.

The decision will enable the University Archives to improve its services to the uni-

versity community and to the public. For the NBAC, it means there is now a stable base from which it can continue its role of promoting the national record of Australian business, labour, rural and industry activity. Administrative arrangements for the change are being finalised at the moment. A meeting of the Advisory Committee will be held after mid-September.

The staff are deeply grateful for the support they have received over the last year from the Friends of the NBAC, the NTEU and their professional colleagues.

National communications fund

The \$52.2 million National Communications Fund (NCF) is the next stage of the commonwealth Government's response to the telecommunications Service Inquiry. The aim of the NCF is to support significant telecommunications projects in the education and health sectors in regional Australia. The NCF is a competitive grants program that will give priority to projects that not only improve the delivery of education and health services, but also improve telecommunications services in regional communities.

Stakeholders have been invited to provide comments on the draft guidelines for the NCF fund. Public comment will assist the government in fine tuning the guidelines and make sure they reflect the needs of the regional health and education sectors.

Indigenous telecommunications study

The Commonwealth Government has commissioned a study into telecommunications services for regional, rural and remote indigenous communities. The study will seek information and views on a range of issues such as current service levels, needs of communities and barriers to delivery of services.
