Professional activities: ALIA Director 2001–2003; convenor/president ALIA NSW Library Technicians Group 1999–2003; Member of Parramatta City Council Library Advisory Committee 1991–1999.

Statement of professional concerns: ALIA as the professional association for the information and library sector needs to continue to represent and communicate with its members and on behalf of its members in a transparent and consultative manner. While there have been some changes over the past few years I believe these are only the beginning. As our sector faces the rapidly changing demands of information profession, ALIA needs to continuously monitor and modify its response to the sector's needs. Quality professional development opportunities need to be available, accessible and relevant to all members whether metropolitan or regional based. Active promotion of the benefits of ALIA membership to library and information staff at all levels is required.

Statement of professional concerns: The profession needs a vision for the future which embodies the Association's values, and takes a realistic view of the competitive information environment. The ALIA Board of Directors must articulate a clear direction which is based on sound strategic and financial plans and which can be implemented through supporting the ALIA executive director. An assessment of ALIA's restructure is timely — has it achieved its purpose and objectives from the points of view of all stakeholders, including members?

The LISEKA project will be instrumental in creating a competency framework for career-long education and a reinvigorated profession. CPD will be a large component of this and needs a practical business model offering opportunities to members and outlining roles and responsibilities.

Librarianship can model evidence-based practice — REAP (Research Exchange and Partnership program) is one means of supporting this. ■
