An Act to amend the Copyright Act 1968

BE IT ENACTED by the Queen, and the Senate and the House of Representatives of the Commonwealth of Australia, as follows:

Short title, &c.

- 1. (1) This Act may be cited as the Copyright Amendment Act 1981.
- (2) The Copyright Act 1968¹ is in this Act referred to as the Principal Act.

Commencement

2. This Act shall come into operation on a date to be fixed by Proclamation.

Reproduction for purpose of broadcasting

- 3. Section 47 of the Principal Act is amended—
- (a) by omitting from sub-section (5) "are delivered, with the consent of the National Librarian, to the National Library" and substituting "are delivered, with the consent of the Director-General of the Australian Archives, to the Australian Archives"; and

(b) by adding at the end thereof the following sub-section:

"(6) The Director-General of the Australian Archives shall not consent to the delivery to the Australian Archives in accordance with sub-section (5) of a record or film unless he has certified that the record or film is of an exceptional documentary character.".

Reproduction for purpose of including work in television broadcast

- 4. Section 70 of the Principal Act is amended—
- (a) by omitting from sub-section (5) "are delivered, with the consent of the National Librarian, to the National Library" and substituting "are delivered, with the consent of the Director-General of the Australian Archives, to the Australian Archives"; and

- (b) by adding at the end thereof the following sub-section:
 - "(6) The Director-General of the Australian Archives shall not consent to the delivery to the Australian Archives in accordance with sub-section (5) of a film unless he has certified that the film is of an exceptional documentary character.".

Making of record embodying sound recording for purpose of broadcasting

- 5. Section 107 of the Principal Act is amended—
- (a) by omitting from sub-section (5) "are delivered, with the consent of the National Librarian, to the National Library" and substituting "are delivered, with the consent of the Director-General of the Australian Archives, to the Australian Archives"; and

- (b) by adding at the end thereof the following sub-section:
 - "(6) The Director-General of the Australian Archives shall not consent to the delivery to the Australian Archives in accordance with sub-section (5) of a record unless he has certified that the record is of an exceptional documentary character.".
