An Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June, One thousand nine hundred and forty-two for the purposes of Additions, New Works, Buildings, &c., and to appropriate such sum.

[Assented to 3rd December, 1941.]

BE it enacted by the King's Most Excellent Majesty, the Senate, Preamble.
and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows :—

1. This Act may be cited as the *Appropriation (Works and Buildings) Act 1941-42.* Short title.

2. This Act shall come into operation on the day on which it receives the Royal Assent. Commencement.

3. The Treasurer may issue out of the Consolidated Revenue Fund and apply towards making good the supply hereby granted to His Majesty for the service of the year ending the thirtieth day of June, One thousand nine hundred and forty-two the sum of Three million eight hundred and thirty-one thousand pounds. Issue and application of
£3,831,000.

4. The sum granted by this Act is appropriated for the purposes and services expressed in the Schedule to this Act in relation to the financial year ending the thirtieth day of June, One thousand nine hundred and forty-two. Appropriation.
