

## FLAX AND LINSEED BOUNTIES.

### No. 43 of 1931.

An Act to amend the *Flax and Linseed Bounties Act 1930*.

[Assented to 23rd October, 1931.]

**B**E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title and citation.

1.—(1.) This Act may be cited as the *Flax and Linseed Bounties Act 1931*.

(2.) The *Flax and Linseed Bounties Act 1930*\* is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Flax and Linseed Bounties Act 1930–1931*.

Commencement.

2. This Act shall be deemed to have commenced on the date of the commencement of the Principal Act.

Amendment definition of "flax."

3. Section two of the Principal Act is amended by omitting from the definition of "flax" the word "combed" and inserting in its stead the word "scutched".

## AUSTRALIAN INSTITUTE OF ANATOMY. AGREEMENT.

### No. 44 of 1931.

An Act to ratify and approve an Agreement made between the Commonwealth of Australia and Sir William Colin MacKenzie, Kt., Doctor of Medicine, and for other purposes.

[Assented to 29th October, 1931.]

**B**E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows :—

Short title and citation.

1.—(1.) This Act may be cited as the *Australian Institute of Anatomy Agreement Act 1931*.

(2.) The *Zoological Museum Agreement Act 1924\** is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the *Australian Institute of Anatomy Agreement Act 1924-1931*.

2. Section two of the Principal Act is amended—

- (a) by omitting from sub-section (1.) the words "a National Museum of Australian Zoology" and inserting in their stead the words "an Australian Institute of Anatomy"; and
- (b) by omitting from sub-sections (2.) and (3.) the word "Museum" (wherever occurring) and inserting in its stead the word "Institute".

3. The Agreement made between the Commonwealth of Australia and William Colin MacKenzie, Doctor of Medicine (a copy of which Agreement is set forth in the Schedule to this Act) is ratified and approved.

### THE SCHEDULE.

THIS INDENTURE made the sixteenth day of August One thousand nine hundred and twenty-eight between THE COMMONWEALTH OF AUSTRALIA and WILLIAM COLIN MACKENZIE of 612 St. Kilda Road Melbourne in the State of Victoria. Doctor of Medicine.

WHEREAS this Agreement is supplemental to an Indenture (hereinafter referred to as "The Principal Agreement") made the second day of August One thousand nine hundred and twenty-four between the parties hereto and is intended to be annexed thereto AND WHEREAS the parties hereto desire to vary the terms of the Principal Agreement in manner hereinafter appearing—

NOW THIS INDENTURE WITNESSETH—

1. The Principal Agreement is varied in the manner following that is to say—

- (a) For the words "Minister of State for Home and Territories of the Commonwealth" and "the said Minister" wherever appearing in the body of the Principal Agreement there shall be read the words "the Minister for the time being administering the *Zoological Museum Agreement Act 1924* and any Act amending or in substitution for the same";
- (b) For the words "National Museum of Australian Zoology" and "said Museum" wherever appearing in the Principal Agreement shall be read the words "Australian Institute of Anatomy";

2. Subject only to the variations herein contained the Principal Agreement shall remain in full force and effect.
