1.-(1.) This Act may be cited as the Commonwealth Public short atle and citation. Service Act 1928.

(2.) The Commonwealth Public Service Act 1922-1924* as amended by this Act may be cited as the Commonwealth Public Service Act 1922-1928

2. Section sixty-four of the Commonwealth Public Service Act Attachment of 1922-1924 is amended-

- (a) by omitting from sub-section (3.) the words " and shall pay those sums to the judgment creditor", and inserting in their stead the words "or may direct the deduction therefrom of such sums, and shall pay, or direct the payment of, those sums to the judgment creditor"; and
- (b) by omitting sub-section (9.) and inserting in its stead the following sub-sections :---

"(9.) In this section 'Paying Officer' means_such officer of a Department as the Chief Officer of that Department appoints as Paying Officer for the purposes of this section.

1.—(1.) This Act may be cited as the Referendum (Constitution Alteration) Act 1928.

(2.) The Referendum (Constitution Alteration) Act 1906-1926* is in this Act referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the Referendum (Constitution Alteration) Act 1906-1928.
