An Act to amend section four of the Dairy Produce Export Control Act 1924-1936.

[Assented to 16th September, 1937.]

E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the Dairy Produce Export Control Short title and Act 1937.

- (2.) The Dairy Produce Export Control Act 1924–1936*, as amended by this Act, may be cited as the Dairy Produce Export Control Act 1924 - 1937.
- 2. Section four of the Dairy Produce Export Control Act 1924–1936 is amended by inserting after sub-section (5.) the following subsection:

Australian Dairy Produce

"(5a.) A person shall not be entitled to vote at any election held under the provisions of paragraph (b), (c), (d), (e) or (f) of sub-section (2.) of this section unless he is enrolled as an elector in pursuance of Part VII. of the Commonwealth Electoral Act 1918-1934.".

An Act to amend section four of the Dried Fruits Export Control Act 1924-1935.

E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the Dried Fruits Export Control short title and Act 1937.

(2.) The Dried Fruits Export Control Act 1924–1935*, as amended by this Act, may be cited as the Dried Fruits Export Control Act 1924-1937.

- 2. Section four of the *Dried Fruits Export Control Act* 1924–1935 is amended by inserting after sub-section (5.) the following sub-section:—

THERAPEUTIC SUBSTANCES.

No. 22 of 1937.

An Act relating to Therapeutic Substances and for other purposes.

[Assented to 16th September, 1937.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

Short title.

- 1. This Act may be cited as the Therapeutic Substances Act 1937.
- Commencement.
- 2. This Act shall commence on a date to be fixed by Proclamation.

Definitions.

- 3. In this Act, unless the contrary intention appears—
 "approved overseas manufacturer" means any institution or
 manufacturer declared, in pursuance of this Act, to be an
 - "therapeutic substance" means any substance declared, in pursuance of this Act, to be a therapeutic substance for the purposes of this Act.

approved overseas manufacturer of therapeutic substances;

Application of Act.

4. This Act shall not apply to vaccines prepared from microscopic organisms from the body of any person or animal for use only in the treatment of that person or animal.

Arrangement with State.

5. The Governor-General may arrange with the Governor in Council of any State for officers or authorities of the Commonwealth and officers or authorities of the State to act in aid of each other in preventing the introduction, occurrence or spread of diseases affecting man or animals.

Delegation by Minister.

6.—(1.) The Minister may, by writing under his hand, delegate any of his powers and functions under this Act in relation to any matters or class of matters, or to any particular State or Territory of the Commonwealth, so that the delegated powers and functions may be exercised by the delegate with respect to the matters or class of matters specified, or the State or Territory defined, in the instrument of delegation.
