ESTATE DUTY ASSESSMENT.

No. 34 of 1922.

An Act to amend the Estate Duty Assessment Act 1914-1916.

[Assented to 18th October, 1922.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

Short title and citation.

- 1.—(1.) This Act may be cited as the Estate Duty Assessment Act 1922.
- (2.) The Estate Duty Assessment Act 1914-1916 is in this Act referred to as the Principal Act.
- (3.) The Principal Act, as amended by this Act, may be cited as the Estate Duty Assessment Act 1914-1922.

2. Section seventeen of the Principal Act is amended by inserting Assessable after the word "death" (first occurring) the words "and Federal and residents. State Land and Income Taxes which become due and payable after his death and within one year after the payment of duty on any assessment under this Act.".

3. Section eighteen of the Principal Act is amended by inserting Assessable at the end thereof the words "and Federal and State Land and value for absentees. Income Taxes due and payable at the time of his death or which become due and payable after his death and within one year after the payment of duty on any assessment under this Act.".

4.—(1.) Section thirty-one of the Principal Act is amended by adding at the end thereof the following proviso:-

Remission of penalty duty.

- "Provided that the Commissioner may, in any particular case, for reasons which in his discretion he thinks sufficient, remit the additional duty imposed by way of penalty or any part thereof.".
- (2.) This section shall be deemed to have commenced on the first day of July, One thousand nine hundred and twenty-one.

SOUTH AUSTRALIAN FARMERS' AGREEMENT.

No. 35 of 1922.

An Act to ratify and approve an agreement made between Farmers' Bulk Grain Co-operative Company Limited, the Commonwealth of Australia, and the Honorable Thomas Pascoe, Minister of Agriculture in and for the State of South Australia, acting for and on behalf of His Majesty's Government of the said State.

[Assented to 18th October, 1922.]

DE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

- 1. This Act may be cited as the South Australian Farmers' Shorttille. Agreement Act 1922.
- 2. The Agreement, a copy of which is set out in the Schedule Ratification of Agreement. to this Act, is hereby ratified and approved.
