

# Judges' Remuneration

No. 40 of 1969

An Act relating to the Remuneration of the Judges of Courts created by the Parliament, of the Presidential Members of the Commonwealth Conciliation and Arbitration Commission and of the Members of the Trade Practices Tribunal.

[Assented to 14 June 1969]

**B**E it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1. This Act may be cited as the *Judges' Remuneration Act 1969*. Short title.
2. This Act shall come into operation on the day on which it receives the Royal Assent. Commencement.
3. The Acts specified in the first column of the First Schedule to this Act are amended as respectively specified in the second column of that Schedule. Amendment of Acts.
4. An Act specified in the first column of the Second Schedule to this Act, as amended by this Act, may be cited in the manner specified in the second column of that Schedule opposite to the reference to that Act in the first column. Citation of Acts.
