### An Act to grant and apply out of the Consolidated Revenue Fund a sum for War Pensions.

#### [Assented to 15th August, 1924.]

B<sup>E</sup> it enacted by the King's Most Excellent Majesty, the Senate, Preamble, and the House of Representatives of the Communication and the House of Represent and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows :----

1. This Act may be cited as the War Pensions Appropriation short title. Act 1924.

1.-(1.) This Act may be cited as the Post and Telegraph short title and citation. Rates Act 1924.

(2.) The Post and Telegraph Rates Act 1902-1923 is, in this Act, referred to as the Principal Act.

(3.) The Principal Act, as amended by this Act, may be cited as the Post and Telegraph Rates Act 1902-1924.

2. This Act shall be deemed to have commenced on the first day commencement. of July One thousand nine hundred and twenty-three.

An Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June One thousand nine hundred and twenty-five for the purposes of Additions, New Works, Buildings, &c., and to appropriate such sum.

**B**<sup>E</sup> it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows :--

1. This Act may be cited as the Appropriation (Works and Buildings) Act 1924-25.

2. The Treasurer may issue out of the Consolidated Revenue Fund and apply towards making good the supply hereby granted to His Majesty for the service of the year ending the thirtieth day of June One thousand nine hundred and twenty-five the sum of Four hundred and three thousand seven hundred and eighty-nine pounds.

**3.** The said sum granted by this Act is appropriated for the purposes and services set forth in the Schedule in relation to the financial year ending the thirtieth day of June One thousand nine hundred and twenty-five.
