- (3.) The Principal Act, as amended by this Act, may be cited as the Excise Act 1901-1934.
- 2. Part XI. of the Principal Act is amended by inserting after section one hundred and forty-seven the following section:—

- "147A.—(1.) Where any convicted person has, whether before or after the commencement of this section, been released in pursuance of section one hundred and forty-seven of this Act upon his giving security for the payment of the pecuniary penalty adjudged to be paid by him, and the penalty has not been paid, or part only-thereof has been paid, the prosecutor or plaintiff may apply to the Court for an order committing the offender to gaol until the penalty, or the balance thereof, as the case may be, has been paid, and the Court shall, if it is satisfied that enforcement of the security is impracticable or would occasion hardship to the surety, make an order accordingly.
- "(2.) The provisions of section one hundred and forty-nine of this Act shall apply to the imprisonment of an offender for whose committal to gaol an order has been made in pursuance of this section:

Provided that, in the calculation of the period at the expiration of which the defendant is to be discharged, there shall be taken into account any period of imprisonment served by the defendant prior to his release upon his giving security for the payment of the penalty:

Provided further, that where the penalty has been paid in part, the amount of penalty, for the purposes of the table contained in section one hundred and forty-nine of this Act, shall be the unpaid balance of the penalty.

"(3.) Notice of an application under this section shall be served

upon the convicted person.".

An Act to revise the Statute Law of the Commonwealth by repealing Enactments which have ceased to be in force or have become unnecessary, to make any Amendments in that Law which are rendered necessary or desirable by any such repeal, and for other purposes.

[Assented to 6th August, 1934.]

E it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

1.—(1.) This Act may be cited as the Statute Law Revision Act 1934.

- (2.) Each Act specified in the first column of the First Schedule to this Act may, as amended by this Act, be cited in the manner specified in the second column of that Schedule opposite the reference to that Act in the first column.
- 2.—(1.) The Acts specified in the Second Schedule to this Act are Repealand hereby repealed:

of Acts.

Provided that any act or thing, which by any Act specified in Part III. of that Schedule was made or deemed lawful valid or effectual, shall, to the extent to which it was so made or deemed lawful, valid or effectual, continue to be or to be deemed lawful valid or effectual.

- (2.) So much of the Acts specified in the Third Schedule to this Act as has not been repealed by any other Act is hereby repealed.
- (3.) The Acts specified in the first column of the Fourth Schedule to this Act are hereby amended as respectively specified in the second column of that Schedule.
- 3. The Acts set forth in the Fifth Schedule to this Act are repealed: Repeator Provided that where the income tax imposed on income by any Acts. Act specified in that Schedule has not been paid, the rate of tax imposed by that Act shall continue to apply to that income as if this section had not been enacted.

4.—(1.) Section nine of and the Schedule to the Committee of Public Accounts Act 1920 are repealed.

An Act to amend sections seventy-three and eighty-four of the Commonwealth Public Service Act 1922-1933.

[Assented to 6th August, 1934.]

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

Short title and citation.

- 1.—(1.) This Act may be cited as the Commonwealth Public Service Act 1934.
- (2.) The Commonwealth Public Service Act 1922-1933* is in this Act referred to as the Principal Act.
- (3.) The Principal Act, as amended by the Statute Law Revision Act 1934† and by this Act, may be cited as the Commonwealth Public Service Act 1922-1934.

Furlough.

2. Section seventy-three of the Principal Act is amended by omitting from sub-section (2.) all the words after the word "the" (last occurring) and inserting in their stead the words "salary for a period of leave not exceeding that which the officer could have been granted under the last preceding sub-section".
