An Act to enable the Director-General of Public Health Elizabeth II, to nominate persons to act in his place on certain No. 12, 1961 boards and committees; for this and other purposes to amend the Public Health Act, 1902, and certain other Acts; and for purposes connected therewith. [Assented to, 22nd March, 1961.]
