- (a) to increase certain fees payable under the *Associations Incorporation Act 1984*, and
- (b) to introduce two new fees relating to the lodgment of a statement of accounts.

This Regulation is made under the *Associations Incorporation Act 1984*, including section 73 (the general regulation-making power) and the sections referred to in the table of fees set out in Schedule 1 to this Regulation.
