

TOURIST BOARD ORDINANCE 1970

475

No. 28 of 1970

An Ordinance to amend the *Tourist Board Ordinance 1962-1967*

[Assented to 7 July, 1970]

BE it ordained by the Legislative Council for the Northern Territory of Australia as follows:—

1. —(1.) This Ordinance may be cited as the *Tourist Board Ordinance 1970*. Short title and citation

(2.) The *Tourist Board Ordinance 1962-1967* is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance as amended by this Ordinance may be cited as the *Tourist Board Ordinance 1962-1970*.

2. This Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the *Gazette*.* Commencement

3. Section 3 of the Principal Ordinance is amended— Definitions

(a) by omitting the definition of "Deputy Chairman" and inserting in its stead the following definition:—

"'First Deputy Chairman' means the First Deputy Chairman of the Board;"; and

(b) by inserting after the definition of "member" the following definition:—

"'Second Deputy Chairman' means the Second Deputy Chairman of the Board;".

4. Section 6 of the Principal Ordinance is amended— Constitution of the Board

(a) by omitting sub-section (4.) and inserting in its stead the following sub-section:—

"(4.) The Administrator in Council shall appoint one of the members of the Board to be the Chairman of the Board, one to be the First Deputy Chairman of the Board and one to be the Second Deputy Chairman of the Board."; and

(b) by omitting sub-sections (6.), (7.) and (8.) and inserting in their stead the following sub-sections:—

“(6.) Subject to this Ordinance, the Chairman, the First Deputy Chairman and Second Deputy Chairman—

- (a) shall hold office as Chairman, First Deputy Chairman and Second Deputy Chairman, respectively, for a period of three years from the date of their respective appointments by the Administrator in Council; and
- (b) may, by notice in writing to the Administrator, resign from office as Chairman, First Deputy Chairman or Second Deputy Chairman, as the case may be.

“(7.) A First Deputy Chairman or a Second Deputy Chairman who is appointed to be Chairman ceases to be First Deputy Chairman or Second Deputy Chairman, as the case may be, immediately before the date of his appointment as Chairman.

“(8.) In the event of a member, the Chairman, the First Deputy Chairman or the Second Deputy Chairman ceasing to hold office prior to the termination of his period of appointment, another member, Chairman, First Deputy Chairman or Second Deputy Chairman, as the case requires, may be appointed in his place for the remainder of that period.”.

5. Section 7 of the Principal Ordinance is amended—

- (a) by omitting from sub-section (1.) the words “Deputy Chairman” and inserting in their stead the words “First Deputy Chairman”.
- (b) by omitting from sub-section (2.) the words “Deputy Chairman” and inserting in their stead the words “First Deputy Chairman”; and
- (c) by omitting from sub-section (3.) the words “Deputy Chairman” and inserting in their stead the words “First Deputy Chairman”;

6. Section 8 of the Principal Ordinance is amended—

- (a) by omitting from paragraph (a) of sub-section (1.) the words “Deputy Chairman” and inserting in their stead the words “First Deputy Chairman”;
- (b) by omitting from paragraph (b) of sub-section (1.) the words “Deputy Chairman” and inserting in their stead the words “First Deputy Chairman”; and
- (c) by omitting from paragraph (d) of sub-section (1.) the words “Deputy Chairman” and inserting in their stead the words “First Deputy Chairman”.
