

WILDLIFE CONSERVATION AND CONTROL ORDINANCE 1970

An Ordinance to amend the *Wildlife Conservation and Control Ordinance 1962-1969*

[Assented to 11 December, 1970]

BE it ordained by the Legislative Council for the Northern Territory of Australia as follows:—

1.—(1.) This Ordinance may be cited as the *Wildlife Conservation and Control Ordinance 1970*. Short title and citation

(2.) The *Wildlife Conservation and Control Ordinance 1962-1969* is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance as amended by this Ordinance may be cited as the *Wildlife Conservation and Control Ordinance 1962-1970*.

2. This Ordinance shall come into operation on the date on which the *Mining Ordinance 1970* comes into operation.* Commencement

3. Section 8 of the Principal Ordinance is amended by omitting from sub-section (1.) the words and figures "*Welfare Ordinance 1954-1961*" and inserting in their stead the words and figures "*Social Welfare Ordinance 1964-1969*". Rangert

4. Section 20 of the Principal Ordinance is amended— Permission to explore, &c., in sanctuaries

(a) by omitting from paragraph (a) of sub-section (1.) the words and figures "prospecting authority under the *Mining Ordinance 1939-1964*" and inserting in their stead the words and figures "exploration licence under the *Mining Ordinance 1939-1970*";

(b) by omitting from sub-section (2.) the words "prospecting authority" (wherever occurring) and inserting in their stead the words "exploration licence";

(c) by omitting from sub-section (3.) the words "prospecting authority" and inserting in their stead the words "exploration licence";

- (d) by omitting from sub-section (3.) the words and figures "*Mining Ordinance 1939-1964*" and inserting in their stead the words and figures "*Mining Ordinance 1939-1970*"; and
- (e) by omitting from sub-section (7.) the words "prospecting authority" and inserting in their stead the words "exploration licence".

Exempt persons

5. Section 23 of the Principal Ordinance is amended by omitting sub-paragraph (ii) of paragraph (c) and inserting in its stead the following sub-paragraph:—

"(ii) an exploration licence granted or renewed under the *Mining Ordinance 1939-1970*;"

Savings

6. Notwithstanding the amendments effected by this Ordinance, where a prospecting authority, granted or renewed under the *Mining Ordinance 1939-1960* as amended by the *Mining Ordinance 1962* or as further amended at any time, is in force at the date of commencement of this Ordinance, the Principal Ordinance continues to apply to and in relation to that prospecting authority so long as it remains in force as if this Ordinance had not been made.
