Regulations under the *Auctioneers, Dealers and Agents Ordinance*

I FREDERICK CHARLES CHANEY, the Administrator of the Northern Territory of Australia, having received the advice of the Administrator's Council, hereby make the following Regulations under the *Auctioneers, Dealers and Agents Ordinance*.

AUCTIONEERS, DEALERS AND AGENTS REGULATIONS

1. These Regulations may be cited as the Auctioneers, Dealers and Agents Regulations. Citation

2. These Regulations shall come into operation on the date of commencement of the *Auctioneers, Dealers and Agents Ordinance* 1970.† Commencement

3. The Auctioneers Regulations, being Regulations No. 3 of 1957, are repealed. Repeal of Regulations 1957, No. 3

- 4.—(1.) Subject to sub-regulation (2.), a form contained in the Schedule to these Regulations shall be completed in accordance with the requirements of the form. Interpretation

(2.) Strict compliance with the forms contained in the Schedule to these Regulations is not necessary and substantial compliance with those forms is sufficient.

5. An application for a licence other than a clerk's licence shall be in accordance with Form 1. Application for licence other than clerk's licence

6. An application for the renewal of a licence other than a clerk's licence shall be in accordance with Form 2. Application for renewal of licence other than clerk's licence

7. An application for a clerk's licence shall be in accordance with Form 3. Application for clerk's licence

8. A licence other than a clerk's licence shall be in accordance with Form 4. Licence other than clerk's licence

Clerk's licence

9. A clerk's licence shall be in accordance with Form 5.

Saving of existing forms of licence

10. An auctioneer's licence or a clerk's licence in force under the Regulations repealed by these Regulations immediately before the date of commencement of these Regulations shall be deemed, on and after that date, to be varied so as to accord with the form prescribed by these Regulations for the corresponding licence.
