AUCTIONEERS, DEALERS AND AGENTS REGULATIONS

- 1. These Regulations may be cited as the Auctioneers, Dealers and Citation Agents Regulations.
- 2. These Regulations shall come into operation on the date of com- Commencement mencement of the Auctioneers, Dealers and Agents Ordinance 1970.†
- 3. The Auctioneers Regulations, being Regulations No. 3 of 1957, are Repeal of Regulations 1957, repealed.
- 4.—(1.) Subject to sub-regulation (2.), a form contained in the Interpretation Schedule to these Regulations shall be completed in accordance with the requirements of the form.
- (2.) Strict compliance with the forms contained in the Schedule to these Regulations is not necessary and substantial compliance with those forms is sufficient.
- 5. An application for a licence other than a clerk's licence shall be in Application accordance with Form 1.

6. An application for the renewal of a licence other than a clerk's Application for licence shall be in accordance with Form 2.

7. An application for a clerk's licence shall be in accordance with Application for Form 3.

8. A licence other than a clerk's licence shall be in accordance with Licence other Form 4.

9. A clerk's licence shall be in accordance with Form 5.

Saving of existing forms of licence

An auctioneer's licence or a clerk's licence in force under the Regulations repealed by these Regulations immediately before the date of commencement of these Regulations shall be deemed, on and after that dete, to be varied so as to accord with the form prescribed by these Regulations for the corresponding licence.
