

Regulations under the *Forestry Ordinance* 1959-1964

I, ROGER LEVINGE DEAN, the Administrator of the Northern Territory of Australia, having received the advice of the Administrator's Council, in pursuance of the powers conferred on me by the *Forestry Ordinance* 1959-1964 and the *Administrator's Council Ordinance* 1959-1963, hereby make the following Regulations.

AMENDMENTS OF THE FORESTRY REGULATIONS†

1. Regulation 14 of the Forestry Regulations is repealed and the following regulation inserted in its stead:—

“ 14. For the purpose of calculating the fee payable for a licence, the licence shall be deemed to commence on the first day of the month next succeeding the month in which the Administrator grants the application for the licence, and to continue in force until the date of expiry specified in the application, or the amended application, as the case requires.”.

2. Regulation 52 of the Forestry Regulations is amended—

- (a) by omitting the words “right, lease or authority granted and in force under” and inserting in their stead the words “right, permit, licence, lease or authority granted and in force under the *Control of Waters Ordinance* 1938-1965, the *Crown Lands Ordinance* 1931-1964,”;
- (b) by omitting the words “*Owania vernicosa*” and inserting in their stead the words “*Owenia vernicosa*”;
- (c) by omitting the words “*Atalaya homiglauca*” and inserting in their stead the words “*Atalaya hemiglauca*”;
- (d) by omitting the words “*Crevillea striata*” and inserting in their stead the words “*Grevillea striata*”.

3. Regulation 53 of the Forestry Regulations is amended—

- (a) by omitting from paragraph (a) the words “right, lease or authority granted and in force under” and inserting in their stead the words “right, permit, licence, lease or authority granted and in force under the *Control of Waters Ordinance* 1938-1965, the *Crown Lands Ordinance* 1931-1964.”;
- (b) by omitting the words “*Callitus intratropica*” and inserting in their stead the words “*Callitris intratropica*”;
- (c) by omitting the words “*Nauclea cordatus*” and inserting in their stead the words “*Nauclea cordata*”;
- (d) by omitting the words “*Cmelina dalrympleana*” and inserting in their stead the words “*Gmelina dalrympleana*”;
- (e) by omitting the words “*Elacocarpus sp.*” and inserting in their stead the words “*Elaeocarpus sp.*”;
- (f) by omitting the words “*Eucalyptus clivigera*” and inserting in their stead the words “*Eucalyptus clavigera*”;
- (g) by omitting the words “*Eucalyptus papuna*” and inserting in their stead the words “*Eucalyptus papuana*”;
- (h) by omitting the words “*Tristania lactiflora*” and inserting in their stead the words “*Tristanca lactiflora*”;
- (i) by omitting the words “*Acacia polystacha*” and inserting in their stead the words “*Acacia polystachya*”;
- (j) by omitting the words “*Beilschmedia sp.*” and inserting in their stead the words “*Beilschmedia sp.*”.

4. Regulation 59 of the Forestry Regulations is repealed and the following regulation inserted in its stead:—

“59.—(1.) Subject to regulation 7 of these Regulations and the next succeeding sub-regulation, the fee payable for a forest products licence is an amount calculated at the rate of Two pounds for each year of the period during which the licence is in force.

“(2.) The fee payable for a forest products licence granted for the sole purpose of taking firewood is Five shillings and in addition Five shillings for each month in excess of one month during which the licence is in force.”.

5. The heading to Part II.—Division 6. of the Forestry Regulations is repealed and the following heading inserted in its stead:—

6. After regulation 62 of the Forestry Regulations the following heading is inserted:—

7. The Schedule to the Forestry Regulations is amended—

- (a) by omitting from Form 13 the words “land hereunder” and inserting in their stead the words “land described hereunder”; and
- (b) by omitting from condition 2. of Form 16 the words “The permit” and inserting in their stead the words “The person”.
