- 1. Regulation 3 of the Firearms Regulations is amended by omitting Parts. the words-

Register f pistol "10. The Register of Pistol Licences shall be maintained in accordance with Form 4 of the Second Schedule.

Register of high powered firearm licences. "10a. The Register of High Powered Firearm Licences shall be maintained in accordance with Form 4a of the Second Schedule.

Production of pistol or high powered firearm.

- "11.—(1.) If a pistol or high powered firearm in respect of which a licence is applied for is in the possession or custody of an applicant at the time when an application is made, the applicant shall, if so required, produce the pistol or high powered firearm to the officer-in-change of the police station at which the application is lodged for inspection by the officer.
- (2.) The officer shall ascertain that the description of the pistol or high powered firearm set out in the application is correct and he shall initial the description of the pistol or high powered firearm in the application.

Renewal of licence.

"12. A person who is the holder of a pistol licence or a high powered firearm licence shall produce his licence for inspection to the officer-incharge of the police station at which the application is lodged when making application for renewal of the licence.

Change of address.

"13. A holder of a pistol licence or a high powered firearm licence shall notify the Registrar in writing of a change of his address.".
