

Regulations under the *Firearms Ordinance 1956-1968*

AMENDMENTS OF THE FIREARMS REGULATIONS†

1. Regulation 3 of the Firearms Regulations is amended by inserting **Parts** after the words and figures—

“Part III.—Pistols and High Powered Firearms (Regulations 6C-13B).”
the words and figures—

“Part IIIA.—Collectors' Licences (Regulations 13C-13D).”.

2. After Regulation 13B of the Firearms Regulations the following Part is inserted:—

“PART IIIA.—COLLECTORS' LICENCES.

“13C. A collector's licence shall be in accordance with Form 11 of the Second Schedule. **Collectors' licences**

“13D. The Register of Collectors' Licences shall be in accordance with Form 12 of the Second Schedule.”. **Register of Collectors' Licences**

3. Form 10 of the Second Schedule to the Firearms Regulations is amended— **Amendment of Form 10**

(a) by omitting from the heading the words “HIGH POWERED FIREARM” and inserting in their stead the words “*PISTOL/HIGH POWERED FIREARM”;

(b) by omitting the words “high powered firearm” (wherever occurring) and inserting in their stead the words “*Pistol/High Powered Firearm”; and

(c) by adding at the foot of the form the following note:—
“* Strike out word or words not applicable”.

4. After Form 10 of the Second Schedule to the Firearms Regulations the following forms are inserted:— **Insertion of new forms**
