By-Laws under the Jabiru Town Development Act

The Jabiru Town Development Authority in pursuance of section 31 of the Jabiru Town Development Act, at a meeting held on 7 June 1984, made the following By-laws and, for the purposes of section 63(2(a) of the Interpretation Act, authorized Geoffrey Ernest Stolz, its Chairman, to sign them.

JABIRU TOWN DEVELOPMENT (CONTROL OF DOGS) BY-LAWS

1. CITATION

These By-laws may be cited as the Jabiru Town Development (Control of Dogs) By-laws.

2. INTERPRETATION

(1) In these By-laws, unless the contrary intention appears -

"controlled dog" means a dog that is -

- (a) registered under the Dog Act; and
- (b) kept by a person residing in Jabiru;

"land" includes buildings;

"public place", for the purposes of these By-laws and the application to Jabiru of the *Dog Act*, in pursuance of a declaration of the Minister under section 17 of the Act, means -

Jabiru Town Development (Control of Dogs) By-laws

- (a) every road, street, footway, court, alley or thoroughfare which the public is allowed to use, notwithstanding that the road, street, footway, court, alley or thoroughfare may be formed on private property; and
- (b) a road, park or other area of land dedicated in accordance with section 25(1) of the Act;

"town area of Jabiru" means the area administered by the Authority.

(2) For the purposes of these By-laws, a person keeps a dog if he has custody or possession of the dog or if the dog, as a result of action taken by him, is ordinarily kept on his land.

3. CONSENT TO BE OBTAINED

A person shall not keep a controlled dog in the town area of Jabiru unless he has obtained consent from the Director under regulation 7(7)(b) of the National Parks and Wildlife Regulations.

Penalty: \$200.

4. DOG TO BE KEPT ON LEASH

A person shall, at all times, keep a controlled dog in a public place on a leash or under effective control.

Penalty: \$200.
