

Regulations under the *Lottery and Gaming Ordinance 1940-1968*

AMENDMENTS OF THE LOTTERY AND GAMING REGULATIONS†

1. Regulation 7 of the Lottery and Gaming Regulations is amended by omitting the words "on a race-course" and inserting in their stead the words "on a licensed race-course or on a licensed dog-racing ground". Applications for totalizator licences

2. Regulation 13 of the Lottery and Gaming Regulations is amended— Payment of dividend
 - (a) by inserting in paragraph (b) of sub-regulation (2.) after the word "horses" the words "or dogs";
 - (b) by inserting in paragraph (c) of sub-regulation (2.) after the word "horses" the words "or dogs";
 - (c) by inserting in sub-regulation (3.) after the word "horse" (twice occurring) the words "or dog";
 - (d) by inserting in sub-regulation (3.) after the word "horses" (wherever occurring) the words "or dogs";
 - (e) by inserting in sub-regulation (4.) after the word "horse" (first occurring) the words "or dog";
 - (f) by inserting in sub-paragraph (i) of paragraph (a) of sub-regulation (4.) after the word "horses" (twice occurring) the words "or dogs";
 - (g) by inserting in sub-paragraph (ii) of paragraph (a) of sub-regulation (4.) after the word "horses" (first occurring and second occurring) the words "or dogs";

- (h) by inserting in sub-paragraph (ii) of paragraph (a) of sub-regulation (4.) after the words "horse or horses" the words ", or dog or dogs,";
- (i) by inserting in sub-paragraph (iii) of paragraph (a) of sub-regulation (4.) after the word "horses" (twice occurring) the words "or dogs";
- (j) by inserting in sub-paragraph (iii) of paragraph (a) of sub-regulation (4.) after the word "horse" the words "or dog";
- (k) by inserting in sub-paragraph (iv) of paragraph (a) of sub-regulation (4.) after the word "horses" (twice occurring) the words "or dogs";
- (l) by inserting in sub-paragraph (iv) of paragraph (a) of sub-regulation (4.) after the word "horse" (twice occurring) the words "or dog";
- (m) by inserting in paragraph (b) of sub-regulation (4.) after the word "horses" (twice occurring) the words "or dogs"; and
- (n) by inserting in sub-regulation (5.) after the word "horse" (wherever occurring) the words "or dog".

Totalizator tickets

3. Regulation 14 of the Lottery and Gaming Regulations is amended—

- (a) by omitting from sub-paragraph (iii) of paragraph (b) the word "name" and inserting in its stead the word "number"; and
- (b) by inserting in sub-paragraph (iii) of paragraph (b) after the word "horse" the words "or dog".

Form 2A

4. Form 2A in the Schedule to the Lottery and Gaming Regulations is amended by inserting after the words "race meeting" the words "or dog-racing meeting".

Form 5

5. Form 5 in the Schedule to the Lottery and Gaming Regulations is amended—

- (a) by inserting after the words "Race Club" the words "(or Company)"; and
- (b) by inserting after the words "licensed race-course" the words "(or licensed dog-racing ground)".

Amendments in relation to decimal currency

6. The Lottery and Gaming Regulations are amended as set out in the Schedule to these Regulations.
