

## Regulations under the *Mining Ordinance* 1939-1960.

### AMENDMENTS OF THE MINING REGULATIONS.†

1. Regulation 102A of the Mining Regulations is repealed and the following regulation inserted in its stead:—

“ 102A. Every mining lease granted under Part V. of the Ordinance shall be in accordance with Lease Form No. 1, Lease Form No. 2, Lease Form No. 3 or Lease Form No. 5 in the Schedule, as the case requires.”.

2. Lease Form No. 1 in the Schedule is amended by omitting the words “YIELDING and paying therefor rent at the rate of Two shillings per acre in advance, and further yielding and paying half-yearly, on or before the thirty-first day of July and January in each year a royalty at the rate of threepence in the pound on the gross value of all gold or minerals obtained from the land hereby demised:” and inserting in their stead the words “YIELDING and paying therefor rent and royalty in accordance with the said Ordinance and the Regulations for the time being in force thereunder:”.

3. Lease Form No. 2 in the Schedule is amended by omitting the words “YIELDING and paying therefor the yearly rent of shillings per acre in advance, and further yielding and paying half-yearly, on or before the thirty-first day of July and January in each year a royalty at the rate of threepence in the pound on the gross value of all gold or minerals obtained from the land hereby demised.” and inserting in their stead the words “YIELDING and paying therefor rent and royalty in accordance with the said Ordinance and the Regulations for the time being in force thereunder:”.

Lease Form No. 3 in the Schedule is amended by omitting the words "YIELDING and paying therefor the yearly rent of One shilling per acre in advance, and further yielding and paying half-yearly, on or before the thirty-first day of July and January in each year a royalty at the rate of threepence in the pound on the gross value of all minerals obtained from the land hereby demised:" and inserting in their stead the words "YIELDING and paying therefor rent and royalty in accordance with the said Ordinance and the Regulations for the time being in force thereunder: ". Lease Form  
No. 3.

5. Lease Form No. 4 in the Schedule is amended by omitting the words "YIELDING and paying therefor the yearly rent of \_\_\_\_\_ per acre in advance, and further yielding and paying half-yearly, on or before the thirty-first day of July and January in each year, a royalty at the rate of threepence in the pound on the gross value of all gold or minerals obtained from the land hereby demised:" and inserting in their stead the words "YIELDING and paying therefor rent and royalty in accordance with the said Ordinance and the Regulations for the time being in force thereunder: ". Lease Form  
No. 4.

6. Lease Form No. 5 in the Schedule is amended by omitting the words "YIELDING and paying therefor the yearly rent of \_\_\_\_\_ per acre, in advance:" and inserting in their stead the words "YIELDING and paying therefor rent and royalty in accordance with the said Ordinance and the Regulations for the time being in force thereunder: ". Lease Form
