AMENDMENTS OF THE INSPECTION OF
MACHINERY REGULATIONS

1. NOTICE FOR CERTAIN TENSILE STRENGTH STEEL

Regulation 17(1) of the Inspection of Machinery Regulations is amended by omitting paragraphs (b), (c) and (d) and substituting the following:

"(b) A.S. 1204: Structural steels (ordinary weldable grades); and

(c) A.S. 1450: Circular and non-circular carbon steel tubes for mechanical and general engineering purposes."

2. REPEAL AND SUBSTITUTION

Regulation 67 of the Inspection of Machinery Regulations is repealed and the following substituted:

"67. ITEMS TO ACCOMPANY APPLICATION

"An application under regulation 66 shall be accompanied by -

- (a) a statutory declaration from the applicant stating that he is not suffering from defective hearing or vision or other infirmity likely to interfere with the efficient and safe discharge of his duties;
- (b) a statement of the applicant's experience signed by the certificate holder who assisted him in acquiring his experience; and
- (c) the fee specified in Schedule 2."

3. REQUIREMENTS FOR A FIRST CLASS ENGINE-DRIVER'S CERTIFICATE

Regulation 75 of the Inspection of Machinery Regulations is amended -

- (a) by omitting paragraph (b) and substituting the following:

"(b) that he has -

- (i) held for a period of not less than 12 months a Second Class Engine-driver's Certificate of Competency granted under the Act or such other certificate which, in the opinion of the examiner, is of an equivalent standard to a Second Class Engine-driver's Certificate of Competency; or
- (ii) had other approved experience on steam engines for 3,000 hours at a rate of not more than 40 hours per week for a period, or aggregate periods, of not less than 2 years;"

- (b) by omitting from paragraph (c) "375 kW" and substituting "10 MW".

4. REQUIREMENTS AND EXAMINATION FOR A FIRST CLASS REFRIGERATING MACHINERY DRIVER'S CERTIFICATE

Regulation 90 of the Inspection of Machinery Regulations is amended by omitting paragraph (a) and substituting the following:

Inspection of Machinery Regulations

- "(a) produce evidence satisfactory to an examiner -
- (i) that he has for 9 months been the holder of a Second Class Refrigerating Machinery Driver's Certificate of Competency during which time he has assisted a holder of a First Class Refrigerating Machinery Driver's Certificate of Competency in the working of refrigerating machinery for 300 hours, at a rate of not more than 40 hours a week, during that period; or
 - (ii) that he has had other approved experience on refrigerating machinery for 2,500 hours at a rate of not more than 40 hours per week for a period, or aggregate periods, of not less than 2 years; and".

5. FEES

Regulation 94 of the Inspection of Machinery Regulations is amended by omitting paragraphs (d) and (e) and substituting the following:

- "(d) application and granting of certificates of competency and interim certificates of competency, and application for lost certificates of competency and interim certificates of competency; and
- (e) lost certificates of inspection."

6. REPEAL AND SUBSTITUTION

Schedule 2 to the Inspection of Machinery Regulations is repealed and the following substituted:
