MOTOR VEHICLES (FEES AND CHARGES) REGULATIONS

| Short title | 1. These Regulations may be cited as the Motor Vehicles (Fees and Charges) Regulations. |
| Commence- ment | 2. These Regulations shall come into operation on a date to be fixed by the Administrator by notice in the <i>Gazette</i> .† |
| Fees and charges | 3. Subject to these Regulations, the fees and charges set out in the Schedule are prescribed fees for the purposes of the <i>Motor Vehicles Ordinance</i> . |
| Reduced registration fees in certain circumstances | 4. (1) In the case of a motor lorry, motor tractor or trailer, owned by a grazier or farmer and used solely for the carting of his own produce or the requisites of his occupation, and not let on hire or for any reward, the fee for registration or renewal of registration of that motor lorry, motor tractor or trailer shall be one-half of the fee which would, except for this sub-regulation, be applicable under the Schedule. (2) In the case of a motor lorry or a trailer owned by a person engaged on his own account, and not in association with more than 2 other persons, in mining, or in hunting or trapping buffaloes, crocodiles, kangaroos or dingoes, and used solely for the purposes of the owner's occupation, the fee for registration or renewal of registration of that motor lorry or trailer shall be one-half of the fee which would, except for this sub-regulation, be applicable under the Schedule. |
