Regulations under the Motor Vehicle Dealers Act

MOTOR VEHICLE DEALERS REGULATIONS

1. CITATION

These Regulations may be cited as the Motor Vehicle Dealers Regulations.

2. APPLICATION FOR LICENCE

- (1) An application under section 10 of the Act for a licence as a dealer—
 - (a) by a corporation shall be-
 - (i) in accordance with Form 1 of Schedule 1; and
 - (ii) signed by at least one director of the corporation; and
- (b) by any other person, shall be in accordance with Form 2 of Schedule 1, and shall be accompanied by such details as required by Form 1 or 2, as the case may be, of Schedule 1.
 - (2) An application under section 13(2) of the Act for a renewal of a licence—
 - (a) by a corporation shall be-
 - (i) in accordance with Form 3 of Schedule 1; and
 - (ii) be signed by at least one director of the corporation; and
- (b) by any other person, shall be in accordance with Form 4 of Schedule 1, and shall be accompanied by such details as required by Form 3 or 4, as the case may be, of Schedule 1.

3. REFEREES

- (1) For the purposes of an application for a licence, a referee shall be a person—
 - (a) who is prepared to verify that, to the best of his knowledge, in respect of an application—
 - (i) by a corporation, a director or manager is a fit and proper person to hold such a position in a corporation which is granted a licence under the Act; or
 - (ii) by any other person, the applicant is a fit and proper person to be granted a licence under the Act;

- (b) who has known the applicant, or in the case of an application by a corporation a director or manager of that corporation, for a period of not less than 12 months:
- (c) who is not a relation of the applicant, or in the case of an application by a corporation a director or manager of that corporation; and
- (d) who is-
 - (i) a person authorized by the *Oaths Act* to administer an oath for any purpose:
 - (ii) a Justice of the Peace;
 - (iii) a Commissioner for Declarations within the meaning of the Statutory Declarations Act 1959 of the Commonwealth;
 - (iv) a barrister or solicitor;
 - (v) a member of the Police Force of the Northern Territory of Australia;
 - (vi) a bank manager;
 - (vii) a magistrate;
 - (viii) a notary public;
 - (ix) a Clerk of a Local Court; or
 - (x) a commissioner for taking affidavits in the Supreme Court of a State or Territory.
- (2) For the purposes of sub-regulation (1)(c), "relation" means—
 - (a) a parent, grandparent, brother, sister, uncle, aunt, nephew, niece or adopted child of the applicant or in the case of an application by a corporation a director or manager of that corporation; or
 - (b) the spouse or *de facto* spouse of the applicant or in the case of an application by a corporation a director or manager of that corporation or of any other person specified in paragraph (a).

4. REQUIREMENTS FOR SECTION 14(5) SIGN

A sign pursuant to section 14(5) of the Act, indicating the address where a dealings register is kept, shall consist of bold black letters, not less than 7 centimetres high and not less than one centimetre wide, on a white background.

5. CONTRACT EXCLUDING STATUTORY WARRANTIES

For the purposes of section 20(8)(a) of the Act, a prescribed contract shall be in accordance with Schedule 2.

6. STATUTORY DECLARATION ON CONTRACT EXCLUDING STATUTORY WARRANTIES

For the purposes of section 20(8)(b) of the Act a prescribed form shall be in accordance with Schedule 3.

7. FORM OF AUTHORIZATION TO SELL

For the purposes of section 21(2) of the Act, an authorization to sell may be in accordance with Schedule 4.

8. REOUIREMENTS FOR SECTION 29 NOTICE

A notice pursuant to section 29 of the Act shall consist of bold black letters, not less than 7 centimetres high and not less than one centimetre wide, on a white background.

9. CONTRACT EXCLUDING CONDITION THAT MOTOR VEHICLE OF STANDARD FIT FOR REGISTRATION

For the purposes of section 49(2)(c) of the Act, a prescribed contract shall be in accordance with Schedule 5.

10. FEES

- (1) Subject to this regulation, the fees set out in Schedule 6 are the prescribed fees for the purposes of the Act.
 - (2) Where an applicant for the issue or renewal of a licence—
 - (a) has been granted a licence or a renewal of a licence; and
 - (b) carries on or intends to carry on, for the term of the licence, the business of a dealer in a partnership with one or more other dealers,

only one licence shall be issued to all the applicants in the partnership, naming each of them as a dealer.
