## Regulations under the Motor Vehicles Ordinance

## AMENDMENTS OF THE MOTOR VEHICLE (MOTOR HIRE CAR) REGULATIONS

1. A reference in these Regulations to a regulation by number shall be read as a reference to the regulation so numbered in the Motor Vehicle (Motor Hire Car) Regulations.
2. These Regulations shall come into operation on a date to be fixed by the Administrator by notice published in the Gazette. $\dagger$
3. Regulation 1 is amended by omitting "Motor" (second occurring).
4. Regulation 25 A is amended by omitting paragraph (b) and substituting the following paragraphs:
"(b) an amount of 44 cents per mile for travel from the place where the hirer enters the hire car and his destination;

## Fare for

private hire cars and public hire cars to which taximeters not fitted
(ba) if the place where the hirer enters the hire car is within an area bounded by an imaginary line drawn at a distance of 100 miles from the boundary of the town of Tennant Creek as constituted and defined by Proclamation dated 21 May 1954 an amount of 2 cents per mile for travel from the place where he enters the hire car and his destination; and".
5. Regulation 32 A is amended-
(a) by omitting sub-regulation (3) and substituting the following sub-regulation;
"(3) The mileage charge is-
(a) for a journey within the taximeter area comprising the area described in the Darwin

[^0]Lands Acquisition Act 1945-33 cents per mile; and
(b) for a journey within the taximeter area comprising the area of the town of Alice Springs within the meaning of the Alice Springs Administration Ordinance- 34 cents per mile, for each mile of the journey travelled by a passenger in the public hire car.";
(b) by omitting from paragraphs (a) and (b) of sub-regulation (4) " 20 cents" and substituting " 22 cents";
(c) by omitting from paragraph (c) of sub-regulation (4) " 5 cents" and substituting " 10 cents"; and
(d) by omitting from sub-regulation (5) " 30 cents for each period of 6 minutes of waiting" and substituting " 6 dollars per hour for the first hour of waiting and one dollar and 40 cents for each period of 15 minutes of waiting after the first hour".
