# By-laws under the *National Parks and Gardens*Ordinance 1959–1967

The Northern Territory Reserves Board, in pursuance of the powers conferred on it by the *National Parks and Gardens Ordinance* 1959-1967, at a meeting held on the First day of December, 1967, made the following By-laws.

## NATIONAL PARKS AND GARDENS (ADMISSION FEES) BY-LAWS

## PART 1.—PRELIMINARY

- 1. These By-laws may be cited as the National Parks and Gardens Citation (Admission Fees) By-laws.
  - 2. In these By-laws---

Definitions

- "The Alice Springs Telegraph Station National Park" means the land described in Part I of the Schedule to these By-laws;
- "the Ayers Rock-Mount Olga National Park" means the land described in Part II of the Schedule to these By-laws;
- "the Berry Springs Recreation Reserve" means the land described in Part III of the Schedule to these By-laws;
- "the Howard Springs Recreation Reserve" means the land described in Part IV of the Schedule to these By-laws;
- "the Katherine Gorge National Park" means the land described in Part V of the Schedule to these By-laws;
- "the Katherine Low Level Reserve" means the land described in Part VI of the Schedule to these By-laws;
- "the Matarinka Pool Reserve" means the land described in Part VII of the Schedule to these By-laws;
- "the Simpson's Gap National Park" means the land described in Part VIII of the Schedule to these By-laws.

Where admission f es are not payable

- 3.—(1.) A fee is not payable for admission to a reserve of a person who is under the age of seventeen years.
- (2.) A fee is not payable for admission to a reserve unless it is prescribed in the next succeeding by-law.

## Admission fees

- 4.—(1.) The fee payable for admission of a person who is of or over the age of seventeen years to the Ayers Rock-Mount Olga National Park is One dollar.
- (2.) The fee payable for admission of a person who is of or over the age of seventeen years to—
  - (a) the Alice Springs Telegraph Station National Park;
  - (b) the Berry Springs Recreation Reserve;
  - (c) the Howard Springs Recreation Reserve;
  - (d) the Katherine Gorge National Park;
  - (e) the Katherine Low Level Reserve;
  - (f) the Mataranka Pool Reserve; or
- (g) the Simpson's Gap National Park, is Ten cents.

#### Season tickets

- 5.—(1.) Notwithstanding the last preceding by-law, the Board may issue season tickets for admission to reserves.
  - (2.) The fee payable for a season ticket is Two dollars.
- (3.) A season ticket shall be in force until the expiration of the thirty-first day of December next following the date of issue and entitles the person to whom it is issued, while it is in force, to enter any reserve without payment of any admission fee at any time when that reserve is open to the public.

Admission fees must be paid 6.—(1.) Subject to the next succeeding clause of this by-law, a person of or over the age of seventeen years, not being the holder of a season ticket that is in force, shall not enter a reserve in respect of which a fee is payable for admission, without having paid that fee.

Penalty: Forty dollars.

- (2.) A person does not commit an offence against this by-law if
  - (a) before or immediately upon entering the reserve he makes a reasonable but unsuccessful search for a person authorized to receive the fee; and
  - (b) if and when payment of the fee is lawfully requested, he pays it immediately.

## Description of Reserves

## Part I

### The Alice Springs Telegraph Station National Park

All that piece or parcel of land in the Northern Territory of Australia containing an area of 1096 acres 0 roods 30 perches more or less being lots 941, 943 and 1686, Town of Alice Springs and being more particularly delineated on Original Survey Plan No. 1239 and Survey Plans B. 139 and B. 179 respectively, lodged in the Lands and Survey Office, Darwin.

#### Part II

## The Ayers Rock-Mount Olga National Park

All that piece of land in the Northern Territory of Australia containing an area of 487 square miles more or less: commencing at the intersection of the parallel of latitude 25 degrees 16 minutes south with the prolongation north of the eastern boundary of an Aboriginal Reserve thence south along the said prolongation to the parallel of latitude 25 degrees 25 minutes south thence west along that parallel to the meridian of longitude 130 degrees 40 minutes east thence north along that meridian to the northeast boundary of the aforesaid Aboriginal Reserve thence southeast along that boundary to the meridian of longitude 130 degrees 45 minutes east thence south along that meridian to the parallel of latitude 25 degrees 16 minutes south thence east along that parallel to the point of commencement.

### Part III

## The Berry Springs Recreation Reserve

Firstly: All that piece of land being section 1570 Hundred of Ayers County of Palmerston Northern Territory of Australia containing an area of 320 acres more or less. Secondly: All that piece or parcel of land in the Northern Territory of Australia being section 1782 Hundred of Ayers County of Palmerston containing an area of 308 acres 1 rood and 20 perches or thereabouts and being more particularly delineated on Survey Plan A276 lodged in the Lands & Survey Office, Darwin.

#### Part IV

#### The Howard Springs Recreation Reserve

Firstly: All that piece of land containing an area of 560 acres more or less being part of Section 411 Hundred of Bagot County of Palmerston Northern Territory of Australia: Commencing at the southeastern corner of Section 411 Hundred of Bagot and bounded thence by part of the northern side of a road westerly 12,000 links thence by lines at an internal angle of 41 degrees 9 minutes 30 seconds northeasterly 10636.4 links and at an internal angle of 138 degrees 50 minutes 30 seconds easterly 4000 links thence by part of the western side of a road at an internal angle of 89 degrees 56 minutes southerly 7000.2 links to the point of commencement.

Secondly: All that piece of land containing an area of 140 acres more or less being part of Section 412 Hundred of Bagot County of Palmerston Northern Territory of Australia; commencing at the southwestern corner of Section 412 Hundred of Bagot and bounded thence by part of the eastern side of a road northerly 7000.2 links thence by a line at an internal angle of 29 degrees 46 minutes southeasterly 8058.3 links thence by part of the northern side of a road at an internal angle of 60 degrees 18 minutes westerly 3999.9 links to the point of commencement.

## Part V

## The Katherine Gorge National Park

All that piece or parcel of land near Katherine in the Northern Territory of Australia being Northern Territory portion 781 containing an area of 56,069 acres more or less; commencing at a point bearing 275 degrees 5 minutes 15 seconds and distant 9030.3 links from trilateration station N.T.S./001 and bounded thence by a line bearing 356 degrees 10 seconds for a distance of 32,000 links, thence by a line bearing 85 degrees 58 minutes 30 seconds for a distance of 120,000 links; thence by a line bearing 176 degrees 10 seconds for a distance of 48,000 links; thence by a line bearing 265 degrees 58 minutes 10 seconds for a distance of 100,887.6 links, thence by a line bearing 306 degrees 10 seconds for a distance of 24,891.6 links to the point commencement, all bearings being true.

## Part VI

### The Katherine Low Level Reserve

All that piece or parcel of land in the Northern Territory of Australia, containing an area of 40 acres 2 roods more or less, being Northern Territory Portion 890 being more particularly delineated on Survey Plan A373 lodged in the Lands & Survey Office, Darwin.

## Part VII

## The Mataranka Pool Reserve

All that piece or parcel of land near the town of Mataranka in the Northern Territory of Australia containing an area of ten acres more or less being Northern Territory Portion 907 and being more particularly delineated on Survey Plan B338 lodged in the Lands and Survey Office, Darwin.

## Part VIII

## The Simpson's Gap National Park

All that piece or parcel of land being Portion No. 528 at Simpson's Gap near Alice Springs, Northern Territory of Australia containing an area of one square mile more or less: commencing at a point 40 chains north of the centre of Simpson's Gap as defined by survey, thence east 40 chains, south 80 chains, west 80 chains, north 80 chains and east 40 chains to the point of commencement, all bearings being true.
