By-laws 1984, No. 12*

By-laws under the *Darwin Port Authority Act*

The DARWIN PORT AUTHORITY, in pursuance of the powers conferred upon it by the *Darwin Port Authority Act*, at a meeting held on 15 March, 1984 made the following By-laws and, for the purposes of section 63(2) of the *Interpretation Act*, authorized Ian Gordon, its Chairman, to sign them.

AMENDMENTS OF THE PORT BY-LAWS

1. NEW BY-LAW

The Port By-laws are amended by inserting after by-law 50 the following:

"50A. URANIUM PRODUCTS ARE PRESCRIBED SUBSTANCE

"(1) In pursuance of section 48(1)(k) of the Act, uranium products are a prescribed substance for the purposes of section 17(2)(g) of the Act and, subject to clause (3), the prescribed rate for that prescribed substance passing through the Port or any part thereof, regardless of whether there is any use of a port facility provided or any benefit is received from an operation carried on by the Port Authority or its agents in the Port, is \$329 per 6.1 metres equivalent unit (T.E.U.) or part thereof.

"(2) The prescribed rate specified in clause (1) for the prescribed substance specified in that clause is payable by the consigner of that substance.

Port By-laws

"(3) Where, but for this clause, the prescribed rate specified in clause (1) would be payable in relation to the prescribed substance specified in clause (1) and that substance has not, in the Territory, been -

(a) unloaded from; or

(b) loaded into,

a vessel, that prescribed rate shall not, by virtue of this clause, be paid or payable in relation to that substance."

2. REPEAL AND SUBSTITUTION

The Port By-laws are amended by repealing Schedule 3 and substituting the following:

WHARFAGE FEES

The scale of charges for wharfage, whether loading or unloading, is -

1.	for imported petroleum products and oils in bulk	\$3.30 per kilolitre or part thereof
2.	for exported petroleum products and oils in bulk	\$0.50 per kilolitre or part thereof
3.	for animals	\$1.00 per animal
4.	for cement in bulk	\$2.55 per tonne or part thereof
5.	for L.P. gas	\$2.55 per tonne or part thereof
6.	for uranium products	\$405 per 6.1 metres equivalent unit (T.E.U.) or part thereof
7.	for bulk sulphur, bulk lime or similar bulk products loaded or unloaded otherwise than by pipeline	\$2.80 per tonne or part thereof
