## Regulations under the Public Health Act

## AMENDMENTS OF THE PUBLIC HEALTH (GENERAL SANITATION, MOSQUITO PREVENTION, RAT EXCLUSION AND PREVENTION) REGULATIONS

1. These Regulations shall come into operation on 1 January 1979.

2. Regulation 3 of the Public Health (General Sanitation, Mosquito Prevention, Rat Definitions Exclusion and Prevention) Regulations is amended -

- (a) by omitting the definitions of "Chief Medical Officer" and "Minister";
- (b) by omitting from the definition of "occupier" the words "the surface of any land belonging to the Commonwealth" and substituting "the surface of any land belonging to the Territory or the Commonwealth"; and
- (c) by omitting from the definition of "the sewerage system" the words "provided by or under the authority of the Commonwealth" and substituting "provided by or under the authority of the Territory or the Commonwealth".

3. Regulations 4, 36 and 58 of the Public Health (General Sanitation, Mosquito Prevention, Rat Exclusion and Prevention) Regulations are amended by omitting "Commonwealth of Australia Gazette" (wherever occurring) and substituting "Gazette".

4. Regulations 16 and 31(2) of the Public Health (General Sanitation, Mosquito References to Prevention, Rat Exclusion and Prevention) Regulations are amended by omitting "the Commonwealth" (wherever occurring) and substituting "the Territory or the the Commonwealth".

5. Regulation 17(b) of the Public Health (General Sanitation, Mosquito Prevention, Disposal of Rat Exclusion and Prevention) Regulations is amended by omitting "established by the night-soil or refuse Commonwealth" and substituting "established by the Territory".

## Public Health (General Sanitation, Mosquito Prevention, Rat Exclusion and Prevention) Regulations

Failure to comply with notices 6. Regulation 54 of the Public Health (General Sanitation, Mosquito Prevention, Rat Exclusion and Prevention) Regulations is amended by omitting "a debt due to the Crown" and substituting "a debt due to the Territory".

7. An action duly taken or done before the commencement of these Regulations under or for the purposes of a provision of the Public Health (General Sanitation, Mosquito Prevention, Rat Exclusion and Prevention) Regulations and having effect immediately before the commencement of these Regulations is as valid and effectual as if duly made, taken or done under or for the purposes of that provision as amended by these Regulations, but any action that may be taken or done in respect of an action made, taken or done under or for the purposes of that provision as amended by these Regulations may be taken or done in respect of that first-mentioned action.
