Regulations under the *Veterinary Surgeons Ordinance 1960-1968*

I FREDERICK CHARLES CHANEY, the Administrator of the Northern Territory of Australia, having received the advice of the Administrator's Council, in pursuance of the powers conferred on me by the *Veterinary Surgeons Ordinance 1960-1968* and the *Administrator's Council Ordinance 1959-1963*, hereby make the following Regulations.

AMENDMENTS OF THE VETERINARY SURGEONS REGULATIONS†

1. Regulation 7 of the Veterinary Surgeons Regulations is amended by omitting all words after the word "Ordinance," and inserting in their stead the words "the institutions listed in the Third Schedule to these Regulations are prescribed institutions,".

2. The Third Schedule to the Veterinary Surgeons Regulations is repealed and the following Schedule inserted in its stead:—
