TRADE UNIONS—REGULATIONS RELATING* TO THE REGISTRATION OF TRADE UNIONS

- I, ERNEST MACGREGOR CHRISTIE, Acting Registrar of Trade Unions in the Northern Territory of Australia, by virtue of the *Trade Union Ordinance* No. 13 of 1922, do hereby make the following Regulations to come into force forthwith:—
 - Upon the registration of any Trade Union under the Trade Union Act of 1876 of South Australia and amending Ordinance No. 13 of 1922 of the Northern Territory of Australia, the Registrar shall issue a certificate of Registration in the form of Schedule "A".
 - 2. Pursuant to Section 17 of the Trade Union Act of 1879 of South Australia a demand in the form of Schedule "B" shall be issued by the Registrar for the Northern Territory to the Secretary of each Union registered in the Northern Territory under the aforesaid Act and Amending Ordinance and a return in the form of Schedule "C" giving a general statement showing fully the assets and liabilities of the Union or Unions registered for the year ending December 31st, preceding must be furnished before the last day of the month in which the notice in the form of Schedule "B" shall have issued from the Office of the Registrar for Trade Unions in the Northern Territory aforesaid.

Section 18 of the Act provides for a penalty of five pounds for every officer of any Trade Union who shall fail to comply with the requirements of the Registrar.

"Amending Ordinance No. 13 of 1922 of Northern Territory of Australia." To the Secretary,

Pursuant to section 17 of The Trade Union Act, 1876, I hereby require a general statement showing fully the Assets and Liabilities at 31st December, and the Receipts and Expenditure during the year preceding that date of the above

Regulations in force under the Trade Union Act, 1876 of the State of South Australia, in its application to the Northern Territory, as ammended by the *Trade Union Ordinance* 1922; made on 25th September, 1922; published in the *Gazette* of the Northern Territory on 30th September, 1922.

Section 13 (vi) of the Trade Union Act, 1876 reads as follows:-

[&]quot;13. vi. The Registrar may from time to time make regulations respecting registry under this Act, and respecting the seal (if any) to be used for the purpose of such registry, and the forms to be used for such registry, and the inspection of documents kept by the Registrar under the Act, and generally for carrying this Act into effect.

named Trade Union, and showing separately the expenditure in respect of the several objects of the Trade Union to be prepared, made out and transmitted to the Registrar before the day of 19 .

As the Act entitles every member and depositor on application to the Treasurer or secretary of the Trade Union to receive a copy of such general statement, without payment, it will require to be printed.

I require such statement to contain the particulars indicated, in and to be in the form and of the size of the pattern form which accompanies this requisition.

I further require a like general statement made up to the 31st day of December in each succeeding year to be transmitted to the Registrar before the next following first day of June.

I desire to point out that section 18 of the Act renders every Trade Union, which shall fail to comply with the requirements of the Registrar under section 17 and every officer of such Trade Union liable to a penalty of five pounds.
