E it enacted by the King's Most Excellent Majesty, AMENDMENT Act of 1922. by and with the advice and consent of the Legislative Assembly of Queensland in Parliament assembled, and by the authority of the same, as follows:-

Short title and construction of Act

- 1. This Act may be cited as "The Factories and Shops Acts Amendment Act of 1922," and shall be read as one with *" The Factories and Shops Acts, 1900 to 1920," herein collectively referred to as the Principal Act.
- 2. After section 59A of the Principal Act the following section is inserted:—

Working time in bakery.

"[59B.] Notwithstanding anything contained in this Act in regard to overtime, no person shall engage or be engaged in or in connection with the baking of bread for sale at a time when such person would be prohibited from so engaging or being so engaged by †"The Industrial Arbitration Act of 1916," or by any award, order, or agreement thereunder, if he were an employee within the meaning of that Act."
