EDUCATION (TEACHER REGISTRATION) BY-LAW 1989

[as amended by all amendments that commenced on or before 6 June 1997]

PART 1—PRELIMINARY

Short title

1. This by-law may be cited as the *Education (Teacher Registration) By-law 1989.*

Fees

2. The fees set out in the schedule are the fees payable to the board in relation to the matters mentioned.

Definition

2A. In this by-law—

"approved form" see section 24.

PART 2—REGISTRATION OF TEACHERS

Other particulars required for registration

3. The other particulars¹ about a person required to be entered in the register by the director are—

- (a) the person's former name or names (if relevant); and
- (b) the person's registration number.

Period of initial registration and changes to registration

4.(1) Initial registration is to be for the period ending 31 December following the date of admission to the register.

(2) Any change from time to time in any of the particulars entered in the register with respect to a person shall be notified by that person to the board.

Qualifications and experience for full registration

5. A person shall be entitled to full registration as a teacher if—

- (a) the person has successfully completed a course of teacher education acceptable to the board and not less than 1 year of teaching service to the satisfaction of the board; or
- (b) the person's education, experience and contribution to educational practice are, in the opinion of the board, of sufficient merit to warrant registration; or
- (c) the person has complied in all respects with the requirements of the board during a period of provisional registration.

¹ Section 36(1)(d) of the Act provides as follows—

 $^{^{3}6.(1)}$ A person is registered as a teacher when, on order of the board, the director enters the following details in the register—

⁽d) any other particulars required under a by-law;'.

Qualifications and experience for provisional registration

6.(1) The registration of a person may be provisional if—

- (a) while entitled to be registered in all other respects the person has not completed a period of 1 year of teaching service to the satisfaction of the board; or
- (b) while not entitled to be registered under section 5—
 - (i) the person's education, teacher education, fitness to teach and experience are sufficient, in the opinion of the board, to warrant provisional registration; and
 - (ii) the person satisfies the board that the person will be able within a reasonable time to attain a standard of teacher education and experience acceptable to the board.

(2) The initial period of provisional registration shall not exceed 1 year.

(3) Where a person is admitted to provisional registration as a teacher, the board may require such person to submit to it as and when requested a report from the principal or other person duly authorised in that behalf in the approved form upon the manner in which the person has performed duties as a teacher, together with a recommendation as to the person's suitability for registration.

Retention of name in register

7.(1) A registered teacher may, in the approved form, apply to the board for the retention of the teacher's name in the register for a period of 12 months starting on 1 January in any year.

(2) The application must be made on or before 31 December of the preceding year.

(3) The board must give written notice to a registered teacher of the retention of the teacher's name in the register.

Procedure before the board may cancel registration for failing to apply for retention

7A.(1) This section applies if—

- (a) a person is a registered teacher; and
- (b) the board has not received an application under section 7 from the person asking for the person's name to be retained in the register.

(2) The board must give written notice to the person stating the person's registration must be cancelled by the board unless the person applies, in the approved form, for retention of the person's name in the register within the time stated in the notice.

Authorisation to employ unregistered persons in teaching duties

8.(1) An application to the board for its authorisation under section 43(1) of the Act of the employment in a school as a teacher of a person who is not a registered teacher shall be made in the approved form.

(2) The application must be signed by the principal of the school or other authorised person on behalf of the employer.

(3) The authorisation of the board shall be held by the principal of the school to which the authorisation relates during the period of employment therein specified.

Annual census of teachers

9. The principal of a school or other authorised person on behalf of the employer shall, in respect of all persons employed in teaching duties at the school as at 1 April in each year, furnish to the board within 14 days of that date a return in the approved form.

Rules

11.(1) The board may, by resolution, make rules for the purposes of this part.

(2) As soon as practicable after making a rule, the board must, by gazette notice, state—

- (a) that a rule has been made; and
- (b) where a copy may be inspected.

PART 3—ELECTION TO THE BOARD OF REPRESENTATIVES OF REGISTERED TEACHERS

Representatives of registered teachers to be elected

12. The representatives of registered teachers who are nominated for appointment as members of the Board of Teacher Registration under section 3(2)(i) of the Act must be chosen by an election held under this by-law on a date decided by the board.

Roll of electors

13. The director must prepare a roll of electors entitled to vote at any election for the purposes of section 3(2)(i) of the Act comprising the names of all persons who are duly registered as teachers on the date of the publication of the notice of any election.

Notice of election

14.(1) The director must, by gazette notice, give notice about the holding of an election.

(2) The notice shall specify the date fixed for the election and the final date for the receipt of nominations.

(3) The final date for receipt of nominations shall be not less than 21 days after the date of the gazette notice and not less than 30 days before the date fixed for the election.

Nomination of candidates

15.(1) Any 6 persons whose names appear on the roll of electors may nominate an eligible person as a candidate at an election by completing and signing a nomination paper in the approved form.

(1A) Also, the nomination paper must be signed by the person, nominated in the paper as a candidate, as accepting the nomination.

(2) The nomination paper must be received by the director before 4.00 pm on the date specified as the final date for the receipt of nominations

of candidates.

s 16

(3) A person who is not nominated in accordance with this section or who has not accepted such nomination is not entitled to be a candidate at an election.

(4) A candidate may withdraw consent to the candidate's nomination at any time before 4.00 pm on the final date for the receipt of nominations by delivering, or causing to be delivered to the director, a notice of retirement in the approved form.

(5) The director, upon receipt of notice of the death of a candidate may, at any time prior to the forwarding of voting papers and provided that it is practicable so to do, cancel the nomination of that candidate.

Result if no more nominated than number to be elected

16. If no more persons are duly nominated as candidates than are required to be elected, the director must—

- (a) give notice to the Minister about the nominations; and
- (b) declare the persons, nominated as candidates, duly elected by registered teachers for nomination for appointment to the board.

Procedure where more persons nominated than number to be elected

17.(1) If more persons are duly nominated as candidates than are required to be elected, an election must be held and the director must, without unreasonable delay after the final date for receipt of nominations, cause voting papers to be prepared setting out the names of the candidates in an order to be decided by the director by lot and must forward to every person included in the roll of electors at the person's last address recorded in the register a voting paper accompanied by an open envelope addressed to the director and marked 'Voting Paper Only'.

(2) A voting paper shall be in the approved form.

(3) Each voter shall vote for the required number of candidates and indicate his or her vote on the voting paper by placing a cross in the square opposite the name of each of the candidates for whom the voter votes and, if any voter shall vote for more than the required number of candidates or make any other mark or writing on the voting paper, the vote given by the

voter on the voting paper is taken to be informal.

(4) The voter must—

s 18

- (a) enclose the voter's voting paper in the envelope forwarded to the voter under subsection (1); and
- (b) deliver the envelope to the director before 9.00 am on the day fixed for the election.

(5) Every voting paper, when returned to the director, must be deposited in a locked ballot box with a cleft or opening capable of receiving the voting papers.

(6) The director must take the steps the director considers necessary to ensure that only persons duly qualified to vote at an election have voted and that the secrecy of the ballot shall be preserved.

Statement by candidate

18.(1) The director may, at the request of a candidate, include with the ballot paper a statement not exceeding 100 words in length supplied by the candidate.

(2) The candidate may include in such statement the candidate's home address, age, qualifications, experience, current professional position and professional address and such other information as the candidate may desire.

Scrutineers

19.(1) The chairperson of the board must appoint 2 persons to be scrutineers for the examination of the voting papers in respect of an election.

(2) Each candidate may appoint, by written notice, 1 scrutineer to be present when the director opens the envelopes containing the voting papers on the day of the election.

(3) A candidate must give the notice appointing a scrutineer to the director not less than 5 days before the day fixed for the election.

(4) No election shall be invalid by reason of the failure of any candidate to appoint a scrutineer or the failure of a person appointed as a scrutineer to carry out the duties of a scrutineer.

Examination and counting of votes

20.(1) On the day fixed for the election, the director must—

- (a) open the envelopes addressed and returned to the director under section 17; and
- (b) examine the voting papers inside the envelopes.

(1A) The director may appoint persons, other than a candidate, as assistants to help the director in opening the envelopes and examining the voting papers.

(1B) The opening of the envelopes and examining of the voting papers, whether by the director or an assistant, must take place—

- (a) in the presence of the scrutineers; but
- (b) in the absence of the candidates.

(2) If the director is not satisfied that the votes indicated on a voting paper have been cast by a peron duly entitled to vote at the election, the director shall reject the voting paper and the votes on the voting paper must not be counted.

(3) Where a voting paper—

- (a) is manifestly irregular; or
- (b) is so imperfectly executed that the intention of the voter cannot with certainty be ascertained; or
- (c) is taken to be informal under section 17(3);

the director must reject the voting paper and the votes on it must not be counted.

(4) After complying with subsections (1) to (3), the director must proceed to ascertain the number of votes received by each candidate.

(5) Where 2 or more candidates have received an equal number of votes, the director must decide by lot which of the candidates shall be declared elected.

Declaration of result of election

21.(1) When all the voting papers have been examined and the votes

counted, the director must prepare and sign a statement, countersigned by any scrutineers who are present and consent to sign the same, containing the numbers in words as well as figures of the votes for each candidate ascertained under section 20, and must, at the same time and place, declare to have been duly elected the required number of candidates who have received the greatest number of votes.

(2) The director must, by written notice signed by the director, certify to the Minister the names of the candidates so elected, and the date of the declaration of the result of the election.

Disposal of ballot papers

22. (1) After the declaration of the results of an election, the director must keep the ballot papers in a safe place, together with a copy of the roll signed by the director, for at least 1 year.

(2) As soon as possible after the year, the director must destroy the ballot papers and roll.

Election not to be questioned

23. No election is invalid by reason of—

- (a) any defect in the title or any want of title of any person by or before whom such election is held if such person really acted at the election; or
- (b) any formal error or defect in any declaration or other instrument or in any publication made under this by-law or intended to be so made; or
- (c) any such publication being out of time; or
- (d) any delay in holding the election at the time appointed or in taking the poll; or
- (e) any inadvertent failure to deliver or send to any elector any notice or ballot paper; or
- (f) any defect of a merely formal nature.

Approval of forms

24. The board may approve forms for use under this by-law.
