Short title

1. This regulation may be cited as the *Liens on Crops of Sugar Cane Regulation 1994*.

Commencement

2. This regulation commences on 1 April 1994.

Fees

3. The fees payable for the purposes of the Act are set out in the Schedule.

Forms

- **4.(1)** The prescribed forms for the purposes of the Act are the forms approved by the chief executive of the department.
- (2) A person may ask the chief executive for a document setting out an approved form.
 - (3) The chief executive must promptly comply with the request.
