## **Superannuation (Public Employees Portability) Regulation 1998**

### **1 Short title**

This regulation may be cited as the *Superannuation (Public Employees Portability) Regulation 1998*.

### **2 Approved superannuation schemes—Act, s 4(1)**

Each superannuation scheme stated in the schedule is an approved superannuation scheme for the Act.

### **3 Prescribed matters for definition *public employment*—Act, s 4(1)**

For section 4(1) of the Act, definition *public employment*—

- (a) the following States and Territories are prescribed—
  - (i) Queensland;
  - (ii) the Northern Territory; and
- (b) the following authorities are prescribed—
  - (i) Endeavour Foundation;
  - (ii) ETSA Corporation established under the *Electricity Corporations Act 1994* (SA);
  - (iii) a local government;
  - (iv) Queensland Ambulance Service;
  - (v) Queensland Livestock and Meat Authority;
  - (vi) a State electricity entity within the meaning of the *Electricity Act 1994*;
  - (vii) a university established under a law of a State or Territory.

#### **4 Repeals**

The instruments made under the Act as orders in council are repealed.
