#### Short title

**1.** This guideline may be cited as the Sugar Industry (Local Board Award Interim Minimum Price) Guideline 1992<sup>3</sup>.

## Purpose of guideline

**2.** This guideline is made for the purpose of section 8.5(5) of the Act.

## Higher interim minimum price authorised

**3.** An award may determine an interim minimum price or interim minimum prices for sugarcane of up to 100% of the base price or base prices of the sugarcane.
