*By His Excellency GEORGE GREY Esquire Governor and Commander-in-Chief of Her Majesty's Province of South Australia and its Dependencies and Vice-Admiral of the same by and with the advice and consent of the Legislative Council.*

*AN ORDINANCE to alter certain duties of Customs.*

WHEREAS by an Ordinance of the Governor, with the advice and consent of the Legislative Council of South Australia, passed on the twelfth day of August, One Thousand Eight Hundred and Forty-two, intituled, "An Act to amend the Laws for the Regulation of the Customs and Trade in South Australia," among other Duties of Customs there are imposed a discriminating duty of ten per cent. on certain goods, the produce of British Possessions, and the other duties hereinafter mentioned: And whereas it is expedient that the said Duties should be altered in manner after provided:

Preamble.

BE IT THEREFORE ENACTED BY HIS EXCELLENCY THE GOVERNOR of South Australia, with the advice and consent of the Legislative Council thereof: That so far as regards all goods which shall be imported

In lieu of the duties in Schedule A (9 & 10), an *ad valorem* duty of 5 per cent. on British, and 10 per cent. on Foreign goods, not otherwise charged with duty.

imported into the Province after the passing hereof, the following Duties of Customs imposed by the recited Ordinance, and specified in the Schedule thereto annexed marked A, shall cease and be no longer payable; that is to say:

" 9. On Porter, Ale, Beer, Cider, and Perry, imported, a duty of Ten Pounds Sterling for every Hundred Pounds in value thereof, and so in proportion for every greater or less value.

" 10. On all other Goods, Wares, and Merchandize, not being the produce or manufacture of the United Kingdom, imported into this Province or its dependencies from the United Kingdom or elsewhere, a duty of Ten Pounds Sterling for every Hundred Pounds in value thereof, and so in proportion for every greater or less value."

And that in lieu thereof there shall be raised, levied, collected, and paid unto Her Majesty for the public uses of the Province, and support of the Government thereof, on all Goods, Wares, and Merchandize hereafter to be imported into this Province or its Dependencies, the several Duties of Customs set forth in the Schedule hereto annexed.

Commencement and construction.

II. And be it enacted that this Ordinance shall commence from and after the passing thereof, and the same shall be deemed a Law relating to the Customs and Trade, and shall be construed as one Act with the said recited Ordinance.

## SCHEDULE REFERRED TO.

*Table of Duties :*

1. On all Goods, Wares, and Merchandize, not otherwise charged with Duties of Customs and not hereinafter set forth as free of duty, being the growth, produce, or manufacture of the United Kingdom, or of any of the British Possessions abroad, a Duty of Five Pounds Sterling for every Hundred Pounds in value thereof; and so in proportion for every greater or less value.
2. On all Goods, Wares, and Merchandize, not otherwise charged with Duties of Customs and not hereinafter set forth as free of duty, being the growth, produce, or manufacture of any Foreign State, a duty of Ten Pounds Sterling for every Hundred Pounds in value thereof, and so in proportion for every greater or less value.

*Free of Duty :*

Bottles of common glass imported full.

Bullion and Coin.

Horses, Mules, Asses, Sheep, Cattle, and all other live Stock and live animals.

Seeds, Bulbs, and Plants.
