An act to amend the City of Whyalla Commission Act,
1944-1963.

[Assented to 22nd October, 1964.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:—

Short titles.

1. (1) This Act may be cited as the “City of Whyalla Commission Act Amendment Act, 1964”.

(2) The City of Whyalla Commission Act, 1944-1963, as amended by this Act, may be cited as the “City of Whyalla Commission Act, 1944-1964”.

(3) The City of Whyalla Commission Act, 1944-1963, is hereinafter referred to as “the principal Act”.

Incorporation.

2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act.

3. Section 3 of the principal Act is amended—

(a) by striking out the word “The” being the first word in subsection (2) thereof and inserting in lieu thereof the words “Subject to subsection (3) of this section, the”;

(b) by inserting therein after subsection (2) thereof the following subsection:—

(3) The provisions of the Local Government Act which relate to the increase in the number of wards in the area of a municipality shall apply

to the increase of the wards in the area of the City of Whyalla : Provided that the number of wards shall not be increased to more than four.

4. Section 7 of the principal Act is amended—

- (a) by striking out the word "The" being the first word in subsection (1) thereof and inserting in lieu thereof the words "Subject to subsection (7) of this section, the";
- (b) by striking out the word "Three" being the first word in subsection (3) thereof and inserting in lieu thereof the words "Subject to subsection (7) of this section, three";
- (c) by inserting therein after subsection (6) thereof the following subsection :—

(7) If the number of wards in the area of the City of Whyalla is increased to four the Commission shall consist of eight Commissioners four of whom shall be elected Commissioners and shall represent respectively the wards of the City of Whyalla, and such Commissioners shall be elected by ratepayers of the City of Whyalla in the respective wards in accordance with the Local Government Act.

5. Section 26 of the principal Act is amended—

- (a) by striking out the word "All" being the first word in subsection (1) thereof and inserting in lieu thereof the words "Subject to subsection (2) of this section, all";
- (b) by inserting at the end thereof the following subsection (the preceding part of the section as amended by paragraph (a) of this section being designated subsection (1) thereof) :—

(2) All such rates may be assessed and levied upon the annual value as defined by Division II of Part X of that Act if that Division is brought into operation as provided by Division IV of that Part, and the provisions of those Divisions shall apply and have effect accordingly.

6. Subsection (1) of section 27 of the principal Act is amended by striking out the passage "Division IV. of Part X.," therein.
