An Act to amend the Dairy Produce Act, 1934-1946.

[Assented to 5th December, 1974]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

1. (1) This Act may be cited as the "Dairy Produce Act Amendment Act, 1974". Short title.
- (2) The Dairy Produce Act, 1934-1946, is hereinafter referred to as "the principal Act".
- (3) The principal Act, as amended by this Act, may be cited as the "Dairy Produce Act, 1934-1974".

2. This Act shall come into operation on a day to be fixed by proclamation. Commencement.

3. Section 2 of the principal Act is amended— Amendment of principal Act, s. 2—
Interpretation.
 - (a) by inserting after the definition of "board" the following definition:—
"dairy blend" means dairy blend as defined for the purposes of the Dairy Industry Act, 1928-1974;;
 - (b) by inserting in the definition of "dairy produce" after the word "butter" the passage ", dairy blend";
 - and
 - (c) by inserting in the definition of "manufacturer" after the word "butter" the passage ", dairy blend".

4. Section 3 of the principal Act is amended by inserting in paragraph (b) of subsection (2) after the word "butter" the passage "or dairy blend". Amendment of principal Act, s. 3—
Constitution of board.

5. Section 15a of the principal Act is amended— Amendment of principal Act, s. 15a—
Duty of board as to wholesale prices.
 - (a) by inserting in paragraph (a) of the first sentence of that section after the word "butter" the passage "or dairy blend";
 - and
 - (b) by inserting in the second sentence of that section after the word "butter" the passage "or dairy blend."

6. Section 16 of the principal Act is amended—

- (a) by inserting in subsection (1) after the word “butter” the passage
“, dairy blend”;
and
(b) by inserting in subsection (2) after the word “butter” the passage
“, dairy blend”.

Amendment of

s. 17—
Penalty for
exceeding
quota.

7. Section 17 of the principal Act is amended—

- (a) by inserting in subsection (1) after the word “butter”, twice occurring,
the passage “, dairy blend” in each case;
(b) by striking out from subsection (2) the passage “hundredweight or
part of a hundredweight of the butter” and inserting in lieu thereof
the passage “55 kilograms or part of 55 kilograms of the butter,
dairy blend”;
(c) by striking out from subsection (2) the passage “one hundredweight
or more of butter” and inserting in lieu thereof the passage
“55 kilograms or more of butter, dairy blend”;
(d) by inserting in subsection (3) after the word “butter” the passage
“, dairy blend”;
and
(e) by striking out from subsection (3) the passage “ten pounds” and
inserting in lieu thereof the passage “5 kilograms”.

8. Section 20 of the principal Act is amended by inserting in subsection (1)
after the word “butter” the passage “, dairy blend”.
