An Act to amend the Fauna Conservation Act, 1964.

[Assented to 9th December, 1965.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

- 1. (1) This Act may be cited as the "Fauna Conservation Act Amendment Act, 1965".
- (2) The Fauna Conservation Act, 1964, as amended by this Act, may be cited as the "Fauna Conservation Act, 1964-1965".
- (3) The Fauna Conservation Act, 1964, is hereinafter referred to as "the principal Act".

Incorporation.

2. This Act is incorporated with the principal Act and that Act and this Act shall be read as one Act.

Amendment of principal Act, s. 14— Identity cards of inspectors and wardens.

- 3. Section 14 of the principal Act is amended—
 - (a) by inserting after the word "shall" therein the passage "subject to subsection (2) of this section";
 - (b) by inserting the following subsection (the preceding portion of the section being re-designated as subsection (1) thereof):—
 - (2) The provisions of this Part that require an inspector to produce and show an identity card to any person when exercising any power or

doing any act or thing permitted by this Part, shall not apply to a member of the Police Force and such member of the Police Force may exercise any such power or do any such act or thing without producing an identity card to any person.

4. Section 33 of the principal Act is amended by inserting after principal Act, word "land" where it first occurs in subsection (1) thereof the s. 33 the word "land" where it first occurs in subsection (1) thereof the passage "(or any person authorized by such inspector, or owner or occupier of any land)".

Dogs, cats and pests in prohibited sanctuaries.

5. Section 40 of the principal Act is amended by striking Amendment of principal Act, out the passage "fauna reserve, fauna sanctuary or game 5.40 reserve" at the end of subsection (2) thereof.

Permits to take animals and birds.

6. Section 69 of the principal Act is amended by inserting Amendment of principal Act is amended by inserting act is a second act in the principal Act is a second act in t the following subsection (the preceding part of the section being re-designated as subsection (1) thereof):—

Prohibition of transfers of licences or permits.

(2) Nothing in subsection (1) shall be construed as requiring the Minister to make an endorsement on any permit granted pursuant to paragraph (c) of subsection (1) of section 40 of this Act and a permit may be granted thereunder permitting persons, whether on payment of a fee or reward or otherwise, to destroy any animals or birds described in the permit that are causing damage or are likely to cause damage to crops, stock or other property notwithstanding that the Minister has not endorsed such permit as required by subsection (1) of this section.
