An Act to enable the Corporation of the Municipality of Henley and Grange to join in the scheme of Municipal Electric Tramways authorised by the Municipal Tramways Trust Act, 1906.

[Assented to, November 8th, 1917.]

BE it Enacted by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof as with the advice and consent of the Parliament thereof, as follows:

- 1. This Act may be cited as the "Henley and Grange Electric short title. Tramways Act, 1917."
- 2. This Act is incorporated with the Municipal Tramways Trust Incorporation with Act, 1906 (hereinafter called "the principal Act"), and that Act and principal Act. this Act shall be read as one Act.

(c) the definition of "Town Clerk" in section 3 of the principal Act shall be read as including the Town Clerk, or the person for the time being performing the duties of the Town Clerk, of the Municipality of Henley and Grange.

Representation of Suburban Corporations.

4. The present members of the Trust appointed by the Corporations of the Cities of Port Adelaide and Unley and the Towns of Kensington and Norwood, St. Peters, Hindmarsh, and Thebarton shall, subject to the provisions of the principal Act, continue to hold office for the balance of the periods for which they were appointed respectively, but the Corporation of the Municipality of Henley and Grange shall be entitled to take part in every appointment of a member of the Trust by the Suburban Corporations after the passing of this Act.

In the name and on behalf of His Majesty, I hereby assent to this Bill.
