## Private Act (No. 98).

An Act to enlarge the boundaries of the Town of Kensington and Norwood, and for other purposes.

[Assented to, 22nd October, 1878.]

WHEREAS a certain road dividing the Town of Kensington Preambe. and Norwood from the Eastern Park Lands of the City of Adelaide, commonly known as "Dequetteville-terrace," has since the year one thousand eight hundred and sixty-six been made, maintained, and repaired by the Corporation of the Town of Kensington and Norwood, but doubts are entertained whether such road is legally within the limits of the said Corporate Town: whereas the Main Road numbered 31 in the Third Schedule to the "Main Roads Act, 1874," abuts on and runs and extends along the whole of the northerly boundary of Section No. 255, situate in the Hundred of Adelaide, which said Section forms that portion of Kensington and Norwood called Kent Ward: And whereas the Main Road numbered 37 in the Third Schedule to the said "Main Roads Act, 1874," abuts on and runs and extends along the whole of the northern boundaries of the Sections numbered respectively 260 and 277, which said Sections respectively form part of that portion of the Town of Kensington and Norwood called East Norwood Ward and West Norwood Ward respectively: whereas in consequence of the said Main Roads numbered 31 and 37 not being under the care, management, and control of the said Corporation, or within the limits of the said Town of Kensington and Norwood, the said Corporation are unable to expend the rates or other moneys of the said town in the improvements of the footpaths

paths extending along the whole of the said northern boundary of the said Sections numbered 255, 260, and 277, and in consequence thereof the owners and occupiers of the land fronting such roads are put to considerable trouble, and suffer great hardships: And whereas it is expedient to settle such doubts and to include the said strip of land, called Dequetteville-terrace, within the limits of the said town, and also to confer upon the said Corporation the power to lay out and expend money arising from municipal rates, or other moneys, in the formation and repairing of the said footpaths and the watertables on portions of the said Main Roads numbers 31 and 37, so far as they abut on the boundaries of the said town—Be it therefore Enacted by the Governor of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province, in this present Parliament assembled, as follows:

Short title.

1. This Act may be cited as the "Kensington and Norwood Boundaries Act, 1878."

Strip of land known as Dequettevilleterrace to vest in Corporation of Kensington and Norwood, and to form part of Kent Ward.

2. That all that piece of land situate between the westerly boundary of that portion of the Town of Kensington and Norwood called Kent Ward and the East Park Lands of the City of Adelaide, and heretofore called or known as Dequetteville-terrace, and being a piece of land of the width throughout of two hundred links, or thereabouts, commencing at the junction of Dequetteville-terrace aforesaid, and Brownhill Creek Road, Kent Town, with the Main Road numbered 39 in the Third Schedule to the "Main Roads Act, 1874," and running along the south-westerly and west side of Dequetteville-terrace aforesaid throughout its entire length to the junction of Dequettevilleterrace at the northerly end thereof with the southerly side of the Road numbered 28 in the said Third Schedule of the said Main Roads Act, 1874, shall be vested in the said Corporation of the Town of Kensington and Norwood, and shall be within the limits and boundaries of and shall form part of Kent Ward in the said Town of Kensington and Norwood.

Power to Corporation to make and maintain footpath along northern boundary of Kent, East Norwood, and West Norwood Wards.

3. That it shall be lawful for the said Corporation of the Town of Kensington and Norwood from time to time, and at all times hereafter, out of the municipal rates, or other funds of the said town applicable for the purpose of works within the respective wards of the said town, to make, maintain, repair, and keep in repair the footpath forming the south side of the Main Roads, numbered respectively 31 and 37, extending from the north-westerly corner of Kent Ward aforesaid along the whole of the northerly boundary of the said Section numbered 255, forming Kent Ward aforesaid, and also extending along the whole length of the north side of the Sections numbered respectively 260 and 277, in the Hundred of Adelaide aforesaid, and which said last-mentioned Sections form portion of East Norwood Ward and West Norwood Ward respec-And also to make and tively, in the said Town of Kensington and Norwood. that it shall be lawful for the said Corporation, in manner aforesaid, to make, maintain, repair, and keep in repair the watertables along

maintain the water-tables along northerly side of said footpath.

the whole of the northerly side of the said footpaths: Provided Proviso that previous nevertheless, that no such works to be made or entered into in the Main Roads be making, maintaining, and repairing of the said footpaths and watertables shall be made without the previous consent in writing and approbation of the Local Board of Main Roads for the Central District, or other District Board or authority acting under or by virtue of the said "Main Roads Act, 1874," in whom, for the time being, the said roads numbers 31 and 37 in the said Third Schedule to the said in part recited Act are or shall be vested.
